

**AMENDMENT #2
TO DELEGATE AGENCY CONTRACT
WITH
CATHOLIC CHARITIES ARCHDIOCESE OF SAN ANTONIO, INC.**

This amendment ("Amendment") of the Delegate Agency Contract is entered into by and between the City of San Antonio, a Texas municipal corporation ("City") acting by and through its designated representative, the Director of the Department of Human Services, and Catholic Charities Archdiocese of San Antonio, Inc. ("Contractor") acting by and through its designated representative.

WHEREAS, the City presently contracts with Contractor for the Homeless Prevention project pursuant to a Delegate Agency Contract ("Contract") that was originally executed on April 14, 2021 pursuant to Ordinance 2020-06-04-0346; and

WHEREAS, the Contract commenced on January 1, 2021 and was extended to December 31, 2022; and

WHEREAS, the City wishes to provide increased funds for additional services and to extend the term of the Contract effective December 31, 2022 to allow more time to expend the funds; NOW, THEREFORE:

City and Contractor agree to amend the Contract as follows:

1. Section 2.1 is amended to read:

This CONTRACT shall begin on January 1, 2021 and shall terminate September 30, 2023.

2. Section 3.1 is amended to read:

The City will reimburse Contractor in an amount not to exceed \$507,845.95 for costs incurred in accordance with the attached **Budget ("Attachment II")**, and all subsequently authorized Budget Revisions or Budget Amendments to that Budget.

3. Section 3.2 is amended to read:

Funding through this Contract is based on an allocation from the following sources:

\$507,845.95 HEARTH Emergency Solutions Grant – CV CFDA #14.231

Contractor shall comply with the attached **Funding Guide ("Attachment III")**.

4. The documents attached hereto and incorporated herein as “**Scope of Work and Scorecard** (Amendment #2)” and “**Budget** (Amendment #2)” reflect agreed upon revisions to Attachment I, Scope of Work and Scorecard and Attachment II, Budget. The revisions supersede prior conflicting or inconsistent agreements with regard to the referenced documents, and all references in the Contract to the Scope of Work and Scorecard and Budget shall mean as revised by this Amendment.
5. All other terms, conditions, covenants, and provisions of the Contract are hereby continued and shall remain in effect in their original form, except for the provisions modified by this Amendment.

This Amendment is effective December 31, 2022 (the “Effective Date”).
