**AN ORDINANCE**

**AMENDING THE LAND USE PLAN CONTAINED IN THE STINSON  
AIRPORT VICINITY PLAN, A COMPONENT OF THE  
COMPREHENSIVE MASTER PLAN OF THE CITY, BY CHANGING THE  
FUTURE LAND USE OF APPROXIMATELY 31.252 ACRES OF LAND  
LOCATED AT 3730 ROOSEVELT AVENUE, LEGALLY DESCRIBED AS  
31.252 ACRES OUT OF NCB 11177 FROM “COMMUNITY  
COMMERCIAL” TO “MIXED USE”**

**WHEREAS**, the Stinson Airport Vicinity Plan was adopted on April 2, 2009 by City Council as a component of the City’s Comprehensive Master Plan adopted May 29, 1997; and

**WHEREAS**, the Unified Development Code requires consistency between zoning and the Comprehensive Master Plan and Section 213.003 of the TEXAS LOCAL GOVERNMENT CODE allows amendment of the Comprehensive Master Plan following a public hearing and review by the Planning Commission; and

**WHEREAS**, a public hearing was held on January 25, 2023 by the Planning Commission allowing all interested citizens to be heard; and

**WHEREAS**, the San Antonio City Council has considered the effect of this amendment to the Comprehensive Master Plan of the City and has determined that it conforms to the approval criteria set forth in the Unified Development Code §35-420, Comprehensive, Neighborhood, Community, and Perimeter Plans; **NOW THEREFORE**;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The Stinson Airport Vicinity Plan, a component of the Comprehensive Master Plan of the City, is hereby amended by changing the future land use of approximately 31.252 acres of land located at 3730 Roosevelt Avenue, legally described as 31.252 acres out of NCB 11177, from “Community Commercial” to “Mixed Use”. All portions of land mentioned are depicted in **Attachment “I”** attached hereto and incorporated herein for all purposes.

**SECTION 2.** A description of the property is attached as **Attachment “II”** and made a part hereof and incorporated herein for all purposes.

**SECTION 3.** This ordinance shall take effect {Effective Date}.
