**RESOLUTION**

**AUTHORIZING AN INTERLOCAL AGREEMENT WITH BEXAR  
COUNTY TO AFFIRM THE CITY'S ADMINISTRATIVE  
AUTHORITY OVER A PROJECT AREA TO BE DESIGNATED AS A  
TEXAS ENTERPRISE ZONE PROJECT BY BEXAR COUNTY;  
APPROVING BEXAR COUNTY'S NOMINATION TO THE STATE  
OF TEXAS OF THE PROJECT AREA AS A TEXAS ENTERPRISE  
ZONE.**

**WHEREAS**, Chapter 791 of the Texas Government Code authorizes the formulation of interlocal cooperation agreements between and among municipalities and counties for the performance of governmental functions; and

**WHEREAS**, Bexar County is seeking to nominate VHS San Antonio Partners, LLC (DBA Baptist Health System, et al) to the State as a Texas Enterprise Zone Project; and

**WHEREAS**, Texas Government Code §2303.004 requires that before a county makes a nomination of a Texas Enterprise Zone Project, the nominating county must enter into an interlocal agreement with the municipality that has jurisdiction of the territory in which the nominated project or activity will be located and that both the nominating county and municipality approve the nomination; and

**WHEREAS**, the VHS San Antonio Partners, LLC (DBA Baptist Health System, et al) Texas Enterprise Zone Project will be located within the jurisdiction of the City of San Antonio, specifically at 520 Madison Oak Dr., San Antonio, Bexar County, Texas; and

**WHEREAS**, the authorization of the Interlocal Agreement and the approval of Bexar County's nomination to the State of Texas of the project area as a Texas Enterprise Zone shall not be considered a nomination from the City's allotment of designations under Section 2303.406 of the Texas Government Code; **and NOW THEREFORE:**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Council authorizes the City Manager or designee to execute an Interlocal Agreement with Bexar County as required by Texas Government Code §2303.004 for the nomination of VHS San Antonio Partners, LLC (DBA Baptist Health System, et al) as a Texas Enterprise Zone Project, and approves Bexar County's nomination to the State of Texas of the project area as a Texas Enterprise Zone.
