Since 2014, I have interned and worked largely in the public and non-profit sectors including on electoral campaigns. Throughout my college years, I interned with several elected officials including the San Antonio City Council District 7 Office of Councilman Cris Medina, the San Antonio City Council District 4 Office of Rey Saldana, the Office of Congressman Joaquin Castro, and the Office of Stockton Mayor Michael Tubbs. During this time, I learned the basics of how different levels of government operate and the issues that communities face in creating positive change for their residents. After graduating college, I started my full-time professional career working on several political campaigns including for Gina Ortiz Jones for Congress in 2018, Ana Sandoval for District 7 in 2019 and 2021, Melissa Cabello Havrda for District 6 in 2019, Warren for President in 2019 and 2020, and Biden for President in 2020. Over these years, I also had the opportunity to work in the District 6 Office of Councilwoman Melissa Cabello Havrda and the District 7 Office of Councilwoman Ana Sandoval. My experience in these

roles allowed me to better understand how to effectively listen to community needs and address the issues most important to people in our community. Most recently, I currently serve as the Texas Organizing Director for NextGen America, the largest nonprofit organization in the United States focused on engaging and uplifting the voices of young people. In this role, I have managed a team across the state focused on voter registration and engagement on college campuses and in the surrounding community.

Describe your Volunteer Experience & Community Service

Volunteering and community service have always been a central part of my desire to give back to my community. This includes volunteering my time with public institutions, nonprofits, and religious institutions. With the City of San Antonio, I have volunteered and helped organize several community events including backto-school drives, community resources fairs, and community clean-ups. In addition, my volunteer service includes being a District 7 appointee to the City of San Antonio"s 2022 Streets, Bridges, and Sidewalks Bond Committee. Over the years, I have also had the opportunity to volunteer my time at local area schools including being a

judge for the John Jay Science and **Engineering Academy Science Fair** and a Career Day presenter at Connally and Straus Middle Schools. In the non-profit sphere, I have had the opportunity to serve on the New Leaders Council San Antonio Board as our Advancement Chair and Chapter Co-Director. Through New Leaders Council, I have also been able to work with the San Antonio Council for International Visitors to speak with visiting leaders from Mexico and Central and South America. Going on over 20 years, I have been a member of the Prince of Peace Catholic Church Choir and in more recent years have volunteered my time singing with the St. Mary"s University Chapel Choir, St. Michael"s Catholic Church, Holy Redeemer Catholic Church, and Holy Rosary Catholic Church choirs. Throughout these volunteer experiences, I have been able to share my knowledge and talents to better strengthen and give back to my community. By serving on the Streets, Bridges and Sidewalks Advisory Board, I hope to continue this volunteer work.

Please provide a brief narrative outlining your reasons for seeking appointment to this board or commission:

Having spent much of my life living and working in San Antonio"s west and northwest sides, I have come to understand the

significant obstacles that many of our older neighborhoods face in having their longstanding needs addressed. With this perspective in mind, I have made it my mission throughout my career to ensure that I use my training and expertise to make my community better for all of my neighbors. Having first interned and then worked in multiple San Antonio City Council offices, I have experienced firsthand how our local elected leaders work with public works staff to develop an infrastructure plan that will address the needs of neighborhoods across districts and our city. In fact, while serving in the District 7 Office of Councilwoman Sandoval, one of my primary responsibilities was to gather, analyze, and recommend priority infrastructure projects for the city"s Infrastructure Management Program and the 2022-2027 City Bond Program. During this time, I spoke with and read feedback on infrastructure needs from thousands of District 7 neighbors and have become acutely aware of the infrastructure needs across our district. Similarly, another one of my responsibilities while working in the District 7 Office centered on conducting outreach to district stakeholders including local

businesses, nonprofits, and other community organizations. Through this role, our office was able to connect and build relationships with hundreds of community stakeholders during a critical point in the COVID-19 Pandemic, further allowing me to understand the needs of the District 7 community. After having departed the District 7 Office, I later came to serve as a District 7 appointee to the Streets, Bridges, and Sidewalks Bond Committee, which was charged with recommending a slate of projects citywide for the City Council to accept and place on the ballot for voter approval. My time on this committee helped me better understand the needs of not only my district but also the infrastructure needs of districts across the city. Through this committee, I witnessed how community voices can help shape important public projects that benefit neighborhoods, businesses, and residents across our city. Overall, I believe that my experiences working in city government and serving on a 2022 Bond Committee have prepared me to continue using my knowledge and expertise to serve as a District 7 appointee to the Streets, Bridges and Sidewalks Advisory Board.
