San Antonio Food Bank Volunteer (2021-2023): Performed a variety of jobs within the San Antonio Food Bank Warehouse such as sorting donated food items, cleaning facilities, and preparing meals to combat food insecurity among the 100,000 individuals in need for 35 hours. 3. Haven for Hope Community Kitchen (2021-2023): Assisted with the preparation and serving of breakfast, lunch, and dinner meals for residents of Haven for Hope, which is a transformative campus for homeless civilians in San Antonio. Fundraising is ongoing and currently has over \$1,700 thus far. 4. Founder of Cougar Reading Club (2022-2023): Creator of Cougar Reading Club. Provides opportunities for ESL and non-ESL students of Clark High School to deepen their understanding of cultural diversity and the English language. 5. Clark NHS Long Term Service Project: Supporting Custodial Staff (2022-2023): Created a long-term service project to help Clarks custodial staff, which is understaffed by 8 custodians. Formatted a system that allows students (200 Monthly Participants) to sign up for shifts that help clean various areas of the campus. 6. <p>Please provide a brief narrative outlining your reasons for seeking appointment to this board or commission:</p>	<p>Despite being raised by two parents struggling with drug addiction in the West Side of San Antonio, my mother's remarkable resilience propelled her beyond the burdens of childhood poverty and homelessness to obtain a college degree. Similarly, my father, who was illegally brought into this country as an infant, had to overcome not only the struggles of poverty but also the fear of deportation and a linguistic barrier to achieve a college education. Their inspiring journeys, though exceptional in their part of town, have deeply influenced me and sparked my passion for examining social inequalities within my community and seeking opportunities to address them. In a country that prides itself on equal opportunity, it is disheartening to see that Hispanics receive the least education compared to any other racial or ethnic group. Specifically, in the City of San Antonio, one in five Hispanics live below the poverty line. Academic achievement should never be compromised by racial or income inequality. Unfortunately, these implicit biases in the education system hinder the success of many students today. When Mr. Eric Cavazos, a Senior Policy Analyst with the City Council District 8 Office, invited me to apply for the City of San Antonio Higher Education Student Advisory Board, I realized that this esteemed position could be a means for me to address the educational inequalities that my parents once faced and many others continue to face now. As a board member, I would focus on critical socioeconomic issues relating to education, such as the unequal distribution of academic resources, poor retention rates, and limited school funding, which disproportionately affect minority communities. By investing in future generations with an enriched education, we can pave the way for a more equitable society. My passion for public service, coupled with my aspirations to support underprivileged students and provide them with opportunities to thrive despite their circumstances, drives me to believe that I can be a valuable member of HESAB.
