ORDINANCE

APPROVING A CONTRACT WITH KENT POWERSPORTS LP, DBA KENT POWERSPORTS, TO PROVIDE THREE UTILITY VEHICLES (UTVS) AND ONE ALL-TERRAIN VEHICLE (ATV) FOR THE PARKS AND RECREATION DEPARTMENT, PARK POLICE DIVISION, FOR A TOTAL COST OF \$63,441.93. FUNDING OF \$45,342.99 IS FROM THE EQUIPMENT RENEWAL AND REPLACEMENT FUND FY 2023 ADOPTED BUDGET AND FUNDING OF \$18,098.94 IS FROM THE GENERAL FUND FY 2023 ADOPTED BUDGET.

WHEREAS, offers were submitted to provide the City of San Antonio Parks and Recreation Department, Park Police Division, with four off-road utility vehicles; and

WHEREAS, Kent Powersports LP, dba Kent Powersports, submitted an offer to provide three utility terrain vehicles (UTVs) and one all-terrain vehicle (ATV) for a total cost of \$63,441.93; and

WHEREAS, these units will be used by Park Police for routine patrols of nature trails and wild park lands beyond walking paths; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(2), which provides for a procurement necessary to protect the public health or safety; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offer submitted by Kent Powersports LP, dba Kent Powersports, to provide the City of San Antonio three utility terrain vehicles (UTVs) and one all-terrain vehicle (ATV) for a total cost of \$63,441.93 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation and contract are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding for this ordinance in the amount of \$45,342.99 is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5709080 as part of the Fiscal Year 2023 Adopted Budget approved by City Council.

SECTION 3. Funding for this ordinance in the amount of \$18,098.94 is available in Fund 11001000, Cost Center 2608010001 and General Ledger 5709080 as part of the Fiscal Year 2023 Adopted Budget approved by City Council.

SECTION 4. Payment is authorized to Kent Powersports LP, dba Kent Powersports, and should be encumbered with a purchase order.
