**ORDINANCE**

**AWARDING THE 2024 TASK ORDER CONTRACT FOR  
PAVEMENT MARKINGS PACKAGE B IN AN AMOUNT NOT TO  
EXCEED \$3,742,666.80 TO M&M STRIPING & POWER WASHING,  
LLC FOR ROADWAY PAVEMENT MARKINGS LOCATED  
CITYWIDE. FUNDING IS AVAILABLE FROM THE GENERAL  
FUND, THE ADVANCED TRANSPORTATION DISTRICT FUND  
AND NEIGHBORHOOD ACCESS AND MOBILITY PROGRAM  
CONTINGENT UPON APPROVAL OF THE FY 2024 ADOPTED  
BUDGET.**

**WHEREAS**, as part of the proposed FY 2024 Budget, City Council will be considering the approval of \$8,900,000.00 for the maintenance of citywide pavement markings. This funding will provide for the completion of approximately 949 lane miles of pavement markings annually; and

**WHEREAS**, this task order contract is a capacity-based contract that will be utilized primarily to complete pavement marking maintenance of existing markings on projects identified in the FY 2024 Infrastructure Management Program and additional projects that materialize throughout the contract term within the contract capacity. Work activities will be allocated in the form of task orders as the availability of funds is identified; and

**WHEREAS**, this task order contract will be utilized to complete pavement marking maintenance of existing markings on projects identified in the FY 2024 Infrastructure Management Program and additional projects that materialize throughout the contract term and can be completed within the contract capacity; and

**WHEREAS**, this project was advertised on April 12, 2023, and four (4) bids were received and opened on May 16, 2023, with M&M Striping and Power Washing, LLC submitting the lowest responsive bid; and

**WHEREAS**, this task order contract will be awarded in compliance with 15% Small Business Enterprise (SBE) subcontracting goal set by the Small Business Economic Development Advocacy (SBEDA) Program and the Goal Setting Committee. M&M Striping & Power Washing, LLC is a Small/Minority Business Enterprise (S/MBE) and has committed to meeting the subcontractor participation goal; and

**WHEREAS**, this ordinance accepts the lowest responsive bid and awards the 2024 Task Order Contract for Pavement Markings Package B in an amount not to exceed \$3,742,666.80 to M&M Striping & Power Washing, LLC pending approval of the 2024 annual budget.; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** A contract has been awarded to M&M Striping & Power Washing, LLC. in an amount up to \$3,742,666.80 for Pavement Markings Package B. Funding is contingent upon approval of the FY2024 Adopted Budget.

**SECTION 2.** Funding for this ordinance will be identified when work orders are issued. If funding for any work orders is not previously appropriated, funding will be identified and appropriated through subsequent City Council action. Payment is limited to the amounts budgeted in the Operating, Grants, and/or Capital Budget funding sources identified. All expenditures will comply with Operating, Grants, and/or Capital Budgets for current and future fiscal years.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
