**AN ORDINANCE**

**AUTHORIZING A CONTRACT WITH WELLMED MEDICAL MANAGEMENT, INC. FROM OCTOBER 1, 2023, TO SEPTEMBER 30, 2030, TO PROVIDE HEALTH AND WELLNESS SERVICES AT NO COST TO OLDER ADULTS AGES 60 AND OVER ATTENDING VARIOUS CITY SENIOR CENTER AND NUTRITION SITES. THERE WILL BE NO EXCHANGE OF FUNDS AND NO IMPACT TO THE GENERAL FUND.**

**WHEREAS**, a Request for Proposals (RFP) was released May 12, 2023, for health services at no cost to older adults age 60 and over at various City senior center and nutrition sites; and

**WHEREAS**, health-related services will include free medical and dental services, health risk assessments, health education classes, immunizations, vision and hearing screenings, and oral health evaluations and preventive services, on a daily basis at scheduled City senior center and part-time nutrition sites; and

**WHEREAS**, two proposals were received but only WellMed Medical Management, Inc. (WMMI)'s was responsive; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The execution a contractwith WellMed Medical Management, Inc. to provide health and wellness services at no cost to older adults ages 60 and older at various City senior center and nutrition sites from October 1, 2023 to September 30, 2030, is approved. A copy of the contract in substantially final form is attached and incorporated here for all purposes as **Attachment I**.

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 3.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
