### ORDINANCE

AUTHORIZING THE EXECUTION OF AGREEMENTS RELATED TO THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT'S ORAL HEALTH PROGRAM FOR TERMS ENDING SEPTEMBER 30, 2024 WITH OPTIONS TO RENEW, TO INCLUDE AN AGREEMENT WITH PARENT/CHILD INCORPORATED FOR METRO HEALTH TO PROVIDE IN-KIND DENTAL SERVICES TO CHILDREN ENROLLED IN THE EARLY HEAD START PROGRAM FOR AN AMOUNT NOT TO EXCEED \$10,000.00 PER TERM AND A TOTAL AMOUNT OF \$40,000.00, INCLUSIVE OF RENEWALS, AND AN AGREEMENT WITH REBECCA A. DAVENPORT, D.D.S. TO PROVIDE DENTAL SERVICES FOR AN AMOUNT NOT TO EXCEED \$57,600.00 FOR THE INITIAL TERM AND A TOTAL AMOUNT OF \$172,800.00, INCLUSIVE OF RENEWALS.

**WHEREAS**, on an annual basis, the San Antonio Metropolitan Health District (Metro Health) Oral Health Program provides diagnostic and preventive care to more than 22,000 children living in poverty by providing services in non-traditional settings, such as Head Start, Early Head Start and on campuses of local Title I elementary schools; and

**WHEREAS**, case management services are provided by Metro Health dental staff to ensure participating children receive needed treatment and to connect families to a source of ongoing care in the community; and

**WHEREAS**, additionally, oversight of dental clinic operations requires a licensed dentist per Texas law; and

**WHEREAS**, an agreement with Rebecca Davenport, D.D.S. will allow for a continuation of care for Metro Health patients as well as professional consultation services related to Metro Health's dental clinic operations and community outreach programs; and

**WHEREAS**, professional consultation services will include the development and implementation of program initiatives to improve the oral health of the community, as well as related service delivery plans, performance measures and evaluation activities; and

**WHEREAS**, Metro Health's Oral Health Program provides dental services for 6,332 children enrolled in Head Start and Early Head Start Programs annually; and

**WHEREAS**, Early Head Start is a federally funded program providing early education to children ages 0 to 3 years for family's whose income is at or below the federal poverty guidelines; and

**WHEREAS**, in alignment with Head Start and Early Head Start Program Performance Standards, each enrollee is provided with an on-site limited oral health evaluation performed by a Metro Health dentist; and

WHEREAS, in addition, Metro Health dental staff provides case management services and support for all children identified with "urgent" or unmet dental needs who are uninsured or underinsured for required dental care; and

**WHEREAS**, through the agreement with Parent Child Incorporated (PCI), Metro Health dental staff also connects these children with comprehensive dental care through the UT Health San Antonio, School of Dentistry, Department of Developmental Dentistry clinics for preventative and restorative treatment; **NOW THEREFORE:** 

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or designee, or the Director of the San Antonio Metropolitan Health District or designee, is authorized to execute agreements related to the San Antonio Metropolitan Health District's Oral Health Program for terms ending September 30, 2024 with options to renew, to include an agreement with Parent/Child Incorporated (PCI) for Metro Health to provide in-kind dental services to children enrolled in the Early Head Start Program for an amount not to exceed \$10,000.00 per term and a total amount of \$40,000, inclusive of renewals, and an agreement with Rebecca A. Davenport, D.D.S. to provide dental services for an amount not to exceed \$57,600.00 for the initial term and a total amount of \$172,800.00, inclusive of renewals. A copy of the agreements is attached hereto and incorporated herein for all purposes as **Attachment I and II**.

**SECTION 2.** Funding in the amount of \$47,600.00 for this ordinance is available in Fund 29658000, Internal Order 83600000212 and General Ledger 5201040 as part of the Medicaid 1115 Waiver Program.

**SECTION 3**. Funding in the amount of \$10,000.00 for this ordinance is contingent upon City Council approval of the Fiscal Year 2024 budget in Fund 11001000, Cost Center 3618010004 and General Ledger 5201040.

**SECTION 4**. Payment is authorized to Rebecca Davenport, D.D.S. and should be encumbered with a purchase order.

**SECTION 5**. Funding in the amount of \$10,000.00 for this ordinance is contingent upon City Council approval of the Fiscal Year 2024 budget in Fund 11001000, Cost Center 3618010004 and General Ledger 5201040.

**SECTION 6**. Additional funding is contingent upon City Council approval of the Fiscal Year 2025 and subsequent budgets that fall within the contract terms of this ordinance.

**SECTION 7**. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to

concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 8.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

### POSTING LANGUAGE ON PRIME GOV

Ordinance approving agreements related to the San Antonio Metropolitan Health District's Oral Health Program for terms ending September 30, 2024 with options to renew, to include an agreement with Parent/Child Incorporated for Metro Health to provide in-kind dental services to children enrolled in the Early Head Start Program for amounts not to exceed \$10,000.00 per term and a total amount of \$40,000, inclusive of renewals, funded by the General Fund, and approving an agreement with Rebecca A. Davenport, D.D.S. to provide dental services for an amount of \$57,600.00 for the initial term and a total amount of \$172,800.00, inclusive of renewals. Funding for the agreement is available in the Medicaid 1115 Waiver and FY 2024 General Fund budgets. Funding for future years is dependent upon City Council approval of the annual budget.
