Dangerous animal retrieval is vital to preventing the spread of infectious disease and proactively avoiding injury and harm to the citizenry and pets. The US Department of Health & Human Services - Centers for Disease Control (CDC) asks local citizenry to call the local animal control office to remove stray animals from one's neighborhood since these animals may be un-vaccinated or ill. These vehicles are vital for carrying out the mission laid out by the CDC for public health. The San Antonio community has experienced an increase in animal retrieval calls. This has put a strain on existing resources requiring the need for more animal care officers and animal kennel trucks. The proposed 23 vehicles shall be used in all San Antonio council districts.

The City of San Antonio is committed to the humane treatment of animals. Animal control trucks are custom built to have 9 individual, climate controlled, animal kennels that was developed for the City of San Antonio. Hartstra Manufacturing is the only upfitter in Texas that makes air conditioned, refrigerated, and freezer compartment truck bodies.

The last animal control truck to successfully be received and put into service was January 28, 2021. Through a series of anomalies, no new truck replacements or new fleet additions have successfully been obtained through procedures outlined in Texas Local Government Code Chapter 252. Great effort was made to offer low bids opportunities to the community to provide these vehicles. These attempts have been documented and at this time only vendor has expressed an interest to provide the proposed 23 vehicles, and that is Cavender Grande Ford.
