ORDINANCE

APPROVING A CONTRACT WITH CAVENDER FORD MOTOR COMPANY, LTD., TO PROVIDE 23 ANIMAL KENNEL TRUCKS FOR THE ANIMAL CARE SERVICES DEPARTMENT FOR A TOTAL COST OF \$1,973,929.00. FUNDING IN THE AMOUNT OF \$1,458,991.00 IS FROM THE EQUIPMENT RENEWAL AND REPLACEMENT FUND FY 2023 ADOPTED BUDGET FOR FOUR REPLACEMENT AND 13 ADDITIONAL KENNEL TRUCKS. FUNDING IN THE AMOUNT OF \$514,938.00 IS AVAILABLE FROM THE GENERAL FUND FOR THE PURCHASE OF SIX ADDITIONAL KENNEL TRUCKS CONTINGENT UPON CITY COUNCIL APPROVAL OF THE FY 2024 PROPOSED BUDGET.

WHEREAS, Cavender Ford Motor Company, Ltd., submitted an offer to provide the City of San Antonio with 23 live animal control kennel trucks for the Animal Care Services Department for a total cost of \$1,973,929.00; and

WHEREAS, the San Antonio community has experienced an increase in animal retrieval calls which has put a strain on existing resources requiring the need for more animal care officers and animal kennel trucks; and

WHEREAS, dangerous animal retrieval is vital to preventing the spread of infectious disease and proactively avoiding injury and harm to people and pets; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(2), which provides for a procurement necessary to protect the public health or safety; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offer submitted by Cavender Ford Motor Company, Ltd., to provide the City of San Antonio with 23 live animal control kennel trucks for the Animal Care Services Department for a total cost of \$1,973,929.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation and contract are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding for this ordinance in the amount of \$1,458,991.00 is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5709080 as part of the Fiscal Year 2023 Adopted Budget approved by City Council.

SECTION 3. Funding for this ordinance in the amount of \$514,938.00 is available in Fund 11001000, Cost Center 3702010001 and General Ledger 5701085 is contingent upon City Council approval of the Fiscal Year 2024.

SECTION 6. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
