

**THIRD AMENDMENT TO VIA-PUBLIC IMPROVEMENT DISTRICT
INTERLOCAL AGREEMENT**

FOR VALUE RECEIVED, the receipt and sufficiency of which is hereby acknowledged, this Third Amendment to the VIA-Public Improvement District Interlocal Agreement ("Third Amendment") is entered into by the City Of San Antonio, a Texas Municipal corporation ("City"), acting by and through its City Manager pursuant to and duly authorized by Ordinance No. 2023-09-21-____, passed and approved on September 21, 2023, and VIA Metropolitan Transit, ("VIA") acting by and through its duly authorized representative.

A. City and VIA entered into the "VIA-Public Improvement District" Interlocal Agreement ("Agreement") pursuant to City of San Antonio Ordinance No. 2009-09-10-0695, dated September 10, 2009, and as amended by the First Amendment pursuant to Ordinance No. 2013-09-05-0614, dated September 5, 2013, and the Second Amendment pursuant to Ordinance No. 2015-09-17-0818; and

B. City and VIA agree to amend specific provisions of the Agreement as set out in this Third Amendment:

1. **Section 8** is amended to provide for a ten-year extension of the Agreement and City and VIA mutually agree to exercise such extension and said Agreement shall now have a termination date of September 30, 2033, unless terminated sooner according to provisions of the Agreement. In the event that the Downtown Public Improvement District is terminated or the Third Amended and Restated Contract for Improvements and/or Services in the San Antonio Public Improvement District in the Downtown Area is terminated, this Agreement shall automatically terminate, without any action from either party.

2. **Exhibit B** is deleted in its entirety and replaced with the **Exhibit B** attached to this Ordinance, which shall be incorporated into the Agreement for all purposes.


Except as otherwise expressly modified in this Third Amendment, all terms and provisions of the Agreement are ratified and confirmed and shall remain in full force and effect, enforceable in accordance with their terms.
