

Review of 2023-2024 Head Start/Early Head Start Certification of Health and Safety Screener





Health & Safety Screener Status and Process

As required by Head Start Performance Standards, within the first 45 calendar days of the program year the Department of Human Services Head Start program (DHS Head Start) conducts a Healthy and Safety Screening for each of the 29 Head Start/Early Head Start locations. The DHS Head Start Quality Assurance Team uses an 80-Point checklist to assess compliance in the following core areas: Facilities, Medication Administration, Outdoor Review, Safe Environments, Safety Practices, and Transportation. The EHS Quality Assurance team uses a 58-Point checklist to assess compliance in the following core areas: Classrooms Safety, Safety Procedures & Observations, Facility Layout and Environment, Medical Administration, and Outdoors. In addition, the DHS Head Start program utilizes the Office of Head Start Health and Safety Screener Tool as guidance to include reviewing Human Resources and Staff Training requirements.
