

METES AND BOUNDS DESCRIPTION FOR ZONING CHANGE

A 237.065 acre, more or less, tract of land being a portion of that 2325.9942 acre tract conveyed to Rogers Shavano Ranch, Ltd. by deed recorded in Volume 5553, Pages 103-130 of the Official Public Records of Bexar County, Texas, a portion of that 174.415 acre tract conveyed to Global Evangelism, Inc. by deed recorded in Document No. 20230016556 of the Official Public Records of Bexar County, Texas, a portion of Block 27, Shavano Highlands Unit-6A Replat (Encl) recorded in Volume 20002, Page 2533 of the Plat Records of Bexar County, Texas, a portion of Blocks 27 and 28, Shavano Highlands, Unit 6-A (Enclave), and all of Lot 1, Block 28, Shavano Ranch Road, Phase I recorded in Volume 9726, Page 107 of the Deed and Plat Records of Bexar County, Texas. Said 237.065 acre tract being out of the Collin C. McRae Survey No. 391, Abstract 482, the Madison James Survey No. 2, Abstract 387, and the Adams, Beaty, and Moulton Survey No. 1, Abstract 37, in New City Block 17701 of the City of San Antonio, Bexar County, Texas. Southwesterly, along a non-tangent curve to the left, said curve having a radius of 1975.02 feet, a central angle of 01°20'32", a chord bearing and distance of S 04°38'28" W, 46.26 feet, for an arc length of 46.26 feet to a point;

S 03°58'12" W, a distance of 164.53 feet to a point;

S 87°34'40" E, a distance of 57.96 feet to a point;

S 40°44'26" W, a distance of 552.58 feet to a point;

S 08°01'11" W, at a distance of 130.06 passing the northwest corner of Shavano Highlands, Unit-5 (Enclave) recorded in Volume 20001, Pages 1109-1111 of the Plat Records of Bexar County, Texas, and continuing along and with the west line of said Shavano Highlands, Unit-5 (Enclave) for a total distance of 235.86 feet to a point;

Continuing along and with the west line of said Shavano Highlands, Unit-5 (Enclave), the following bearings and distances:

Southwesterly, along a tangent curve to the right, said curve having a radius of 631.00 feet, a central angle of 13°52'07", a chord bearing and distance of \$55°07'59" W, 152.36 feet, for an arc length of 152.74 feet to a point;

S 62°04'02" W, a distance of 234.86 feet to the south corner of said Lot 1, Shavano Ranch Road, Phase I, said point being the intersection of the northwest right-of-way line of said Shavano Ranch Road with the northeast right-of-way line of said N.W. Military;
