THENCE North $00^{\circ} 18^{\prime} 49^{\prime \prime}$ West, a distance of 830.37 feet along the east property line of said 2.49 acre tract to a $1 / 2$ inch iron rod found in the southerly right-of-way line of W. Mally Boulevard for the most northeasterly corner of said 2.49 acre tract and the most northwesterly corner of the herein described tract;

THENCE North $89^{\circ} 33^{\prime} 29^{\prime \prime}$ East a distance of 131.60 feet along the southerly right-of-way line of W. THENCE South $00^{\circ} 18^{\prime} 49^{\prime \prime}$ East a distance of 830.37 feet along the westerly line of said 1.00 acre tract and a 1.05 acre tract recorded in Volume 17803, Page 1062, of the Official Public Records, Bexar County, Texas, to a $1 / 2$ inch iron rod set for the most southwesterly corner of said 1.05 acre tract and the most southeasterly corner of the herein described tract;

THENCE South $89^{\circ} 33^{\prime} 27^{\prime \prime}$ West a distance of 131.60 feet along the northerly right-of-way line of said W.Villaret Street to the POINT OF BEGINNING.
