On July 26, 2023, the Department was informed by one of the approved artists, Joseph Rogers, who was in the Visual Arts Category, that he would relinquish his grant as he is moving out of state and therefore no longer eligible to receive funding. The next highest scoring artist is George Garza, Jr., in the Media Arts Category.

Staff recommended the next highest scoring applicant, George Garza, Jr. for funding through the FY24 Individual Arts Grant.
