Over 11 years experience in strategic planning, administration of development plans and implementing creative and innovative project management of design/build construction.
Describe your Volunteer Experience & Community Service	Susana Segura, Arte es Vida Project Coordinator and Barrio Historian, has been organizing in the Westside community since 1988. Her work has been with social service agencies, religious groups, youth entities, labor organizations, health awareness services and cultural arts groups but always grassroots organizing. With the demolition of La Gloria, a historic building, she started working alongside community to preserve the working class neighborhoods while making sure not to gentrify the barrio. She is currently working with Esperanza Peace and Justice Center to restore Lerma's Nite Club, the longest running live conjunto music venue in the country, listed on the National Register of Historic Places. Recent battles have included, the Non-Discrimination Ordinance for the City of San Antonio, Hays Street Bridge, and Save Casa Maldonado. As an organizer she is involved in campaigns of social, economic and environmental justice struggles centered around people of color, the working class and the LGBTQ community. On weekends i work with the houseless community and help them to find solutions for challenging life choices and situations. Throughout the year, I help stray dog rescue, rehab and rehoming. I'm very interested in food sovereignty and mutual aid work and help maintain four little free libraries, and now pantries.
Please provide a brief narrative outlining your reasons for seeking appointment to this board or commission:	As a long time community worker, I've dedicated my life to the poorest pockets of San Antonio and feel that the cultural grounding I received from my early home life has helped me to set roots based on peace and justice educational work through the arts. Most of this cultural grounding is coming from various art forms so I would love the opportunity to be a part of a different process that serves arts organizations and the community as a whole. I want to give back to my city and my community that has helped me to live a culturally rich life of learning and service.
