Describe your Volunteer Experience & Community Service

I have served on various committees at MIT since 1978 when I began the first of three non-consecutive five-year terms as a member of the MIT Corporation, its board of trustees. I have chaired the Visiting Committees for the Department of Aeronautics and Astronautics (AA) and the Department of Nuclear Science and Engineering (NSE). I also served two separate terms on MIT's Audit Committee. I currently serve on the Visiting Committees for AA, NSE, Mechanical Engineering, and Music and Theater Arts. I have served as a Life Member of the MIT Corporation since 2005. I was the first employee of Exploration School from 1976 to 1977. I joined the board of Explo in 2004, and still serve on it today. Locally I have interviewed San Antonio high school students interested in attending MIT from 1997 through 2019. I have volunteered for various cleanups, such as Basura Bash and in the Olmos Basin, cleaning up after rain event flooding between 2002 and 2010. I served as a member of the San Antonio Technology Accelerator Initiative (SATAI) until 2008. I served as chair of the board of the Winston School San Antonio from 2000 to 2002.

Please provide a brief narrative outlining your reasons for seeking appointment to this board or commission:

I am concerned about the future of water in San Antonio. Since arriving in San Antonio in 1996, I have observed significant changes in how water behaved in the Olmos Basin during rain events. I have also lived through cycles where the aquifer was high and streams flowed, and through periods of drought when they didn't. It is clear that for San Antonio to continue to thrive, we must pay close attention to the maintenance of our water infrastructure. This committee plays an important role that ensures that SAWS has the resources required to provide this critical infrastructure while allocating the costs of this infrastructure appropriately.
