

**ORDINANCE**

**REAPPOINTING CARLA OBLEDO AS MUNICIPAL COURT PRESIDING JUDGE FOR  
THE REMAINDER OF A TWO-YEAR TERM EXPIRING APRIL 30, 2023.**

**WHEREAS**, Carla Obledo, the Municipal Court Presiding Judge, was appointed in January 2020 to the remainder of an unexpired term ending April 30, 2021 and is eligible for reappointment; and

**WHEREAS**, the Subcommittee of the Municipal Court Advisory Committee, consisting of Chairwoman Councilwoman Melissa Cabello Havrda (District 6), Councilman Jalen McKee-Rodriguez (District 2) and Councilwoman Phyllis Viagran (District 3), met on October 8, 2021 to interview the judge, the only applicant for the position, and found she meets the qualifications for the office and outlined goals for the Courts that meet the Subcommittee’s expectations, and voted to bring its recommendation forward for full Council consideration; and

**WHEREAS**, after review and consideration of the qualifications and performance of Judge Carla Obledo for Municipal Court Presiding Judge, the City Council finds that it is in the best interests of the City to reappoint her;  
**NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Carla Obledo is reappointed Municipal Court Presiding Judge for the City of San Antonio Municipal Court for the remainder of a two-year term ending April 30, 2023.

**SECTION 2.** Annual salary for the Municipal Court Presiding Judge is \$145,000.00, with added monthly car allowance of \$500.00. Life insurance and health and retirement benefits currently extended to City employees are extended to Presiding Judge.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This ordinance is effective immediately upon the receipt of eight affirmative votes, or, in the event eight affirmative votes are not received, ten days after passage.
