Item #6 – Dilapidated Structure Case #23311080

1544 Brighton St.

Owner: Maldonado, Jesus R.

1544 Brighton St. is a residential single-family structure. Bexar County Appraisal District shows that Maldonado, Jesus R. is the title owner. The owner, Jesus Maldonado, provided testimony. Joshua Barrientes, Dangerous Premises Officer, with the City of San Antonio Code Enforcement Section found that the property is a public nuisance meeting the definitions of a dangerous building found in City Code Article VIII, Section 6-157, for the main structure, sub-sections 1, 2, 5, 7, 8, 11, 12, and 15; for the accessory structure, sub-section 2, 5, 7, 8, 12, 15, and 17. All notices were issued as required with the first notice issued on August 14, 2019. Staff recommends demolition.

The Board found the property to be a public nuisance. A motion was made by Ms. Brown to demolish the main and accessory structure within 30 days. It is also ordered that the vacate order be enforced. It is further ordered that the utilities be disconnected. Jesse Zuniga seconds the motion.

Item #7 – Dilapidated Structure Case #23355381

267 Castroville Rd.

Owner: Sanchez, Crispin & M. M.

267 Castroville Rd. is a residential single-family structure. Bexar County Appraisal District shows that Sanchez, Crispin & M. M. are the title owners. The owners were not present to provide testimony. SAPD Officer, Diana Brown, provided testimony. Joshua Barrientes, Dangerous Premises Officer, with the City of San Antonio Code Enforcement Section found that the property is a public nuisance meeting the definitions of a dangerous building found in City Code Article VIII, Section 6-157, for the main structure, sub-sections 2, 4, 5, 7, 8, 11, 12, 15, and 17; for the accessory structure, sub-section 5, 8, 11, 12, 15, and 17. All notices were issued as required with the first notice issued on November 20, 2019. Staff recommends demolition.

The Board found the property to be a public nuisance. A motion was made by Celencia Guillory to vacate and demolish the main and accessory structure within 30 days. It is also ordered that the property be secured. It is further ordered that the case be prioritized after the 30 days. Jesse Zuniga seconds the motion.

Item #8 – Dilapidated Structure Case #29000170

741 S. San Bernardo Ave.

Owner: Romero, Francisco Est. Of

(accessory structure)

741 S. San Bernardo Ave. is an accessory structure. Bexar County Appraisal District shows that Romero, Francisco Est. Of is the title owner. The owner was not present to provide testimony. SAPD Officer, Johnny Perez, provided testimony. Ramiro Guerra, Dangerous Premises Officer, with the City of San Antonio Code Enforcement Section found that the property is a public

nuisance meeting the definitions of a dangerous building found in City Code Article VIII, Section 6-157, for the accessory structure, sub-sections 1, 2, 5, 6, 7, 8, 11, 12, 15, 17, and 18. All notices were issued as required with the first notice issued on May 4, 2021. Staff recommends demolition.

The Board found the property to be a public nuisance. A motion was made by Ms. Brown to demolish the accessory structure within 30 days. It is also ordered that the vacate order be enforced. Fred Andis seconds the motion.

Item #9 – Dilapidated Structure Case #23320838

1818 E. Crockett St.

Owner: Lasonya West

1818 E. Crockett St. is a residential single-family structure. Bexar County Appraisal District shows that Lasonya West is the title owner. The owner was not present to provide testimony. Connie Paquette, Dangerous Premises Officer, with the City of San Antonio Code Enforcement Section found that the property is a public nuisance meeting the definitions of a dangerous building found in City Code Article VIII, Section 6-157, for the main structure, sub-sections 1, 2, 5, 7, 8, 11, 12, 15, 17, and 18. All notices were issued as required with the first notice issued on August 27, 2019. Staff recommends demolition.

The Board found the property to be a public nuisance. A motion was made by Celencia Guillory to demolish the main structure within 30 days. It is also ordered that the vacate order be enforced and the property be secured. It is further ordered that the electric meter be removed. Fred Andis seconds the motion.

5-0-0 vote.
