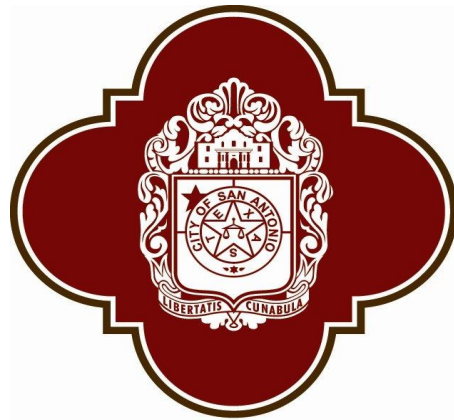

SUBJECT:

Consideration of At-Large Applicants to the Airport Advisory Commission (19 Slots)

SUMMARY:

The Transportation and Mobility Committee will review and recommend applicants for 19 available slots to the Airport Advisory Commission (AAC). The Airport Advisory Commission (AAC) is comprised of 19 members appointed by City Council At-Large for staggered two-year terms. At the October 19, 2021 meeting, the Transportation and Mobility Committee interviewed five candidates from a short-listed list for the Business Category of the Airport Advisory Commission. At the October meeting, the Committee moved to consider three of those interviewed as part of the recommended slated at the November 16, 2021 Transportation and Mobility Council Committee meeting.

BACKGROUND INFORMATION:

The purpose of the AAC is to advise the Aviation Director on matters affecting the San Antonio Airport System and air transportation initiatives. The AAC membership includes representatives from the following categories:

- One Airport Business - Lessee;
- One Alamo Area Council of Governments (AACOG) Representative; and
- Three Aviation Industry representatives;
- Four Business Community Representatives
- Six Community Representatives
- One Federal Aviation Administration (FAA) Representative.
- One Ground Transportation Industry Representative;
- Two Travel and Tourism Industry Representatives;

The City issued two press releases for openings for the AAC on January 22, 2020 and October 16, 2020 which were advertised on the City's website, the Airport and City's social media sites and TVSA. The Office of the City Clerk continuously accepts applications for the AAC.

The AAC membership includes has 13 members and 6 vacancies.

ISSUE:

At the October 19, 2021 meeting of the Transportation and Mobility Committee, the members interviewed five of seven selected applicants for the Business Category after two of the selected applicants declined to be interviewed.
