**PRIORITY 1** = Injured, cruelty, critical bites, and SAPD/FD assistance. 3 hour SLA.

**PRIORITY 2** = Aggressive behavior by roaming pets, trapped/confined animals. 12-24 hour SLA.

**PRIORITY 3** = Non-critical bites/scratches, neglect, aggressive behavior by contained pet. 3-7 day SLA.

**PRIORITY 4** = Public nuisance and permit requests. 10-30 day SLA.

**PRIORITY 5** = Uninjured and friendly roaming dogs. No SLA but utilizes information to make proactive decisions.

### SHELTER INTAKE

"Impounded & RTOed in Field" are pets that were impounded and immediately returned to their owner by the impounding Officer. These pets did not take up any kennel space at ACS.

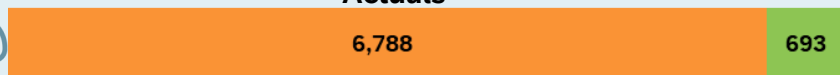

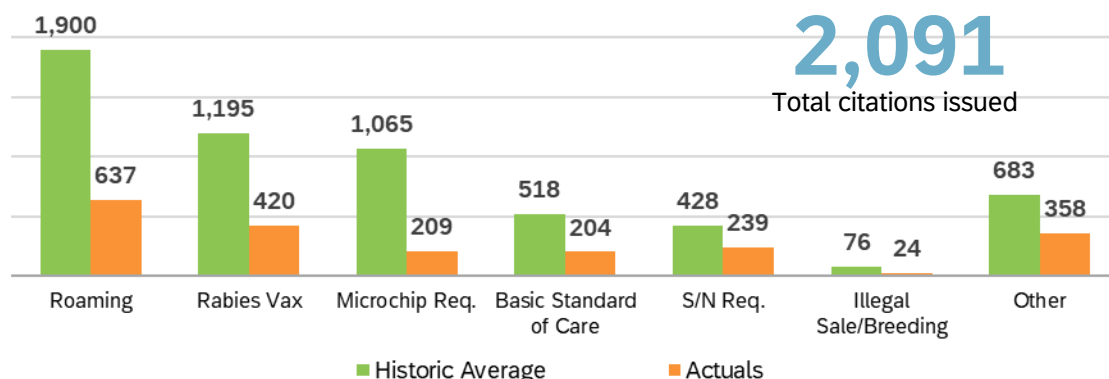

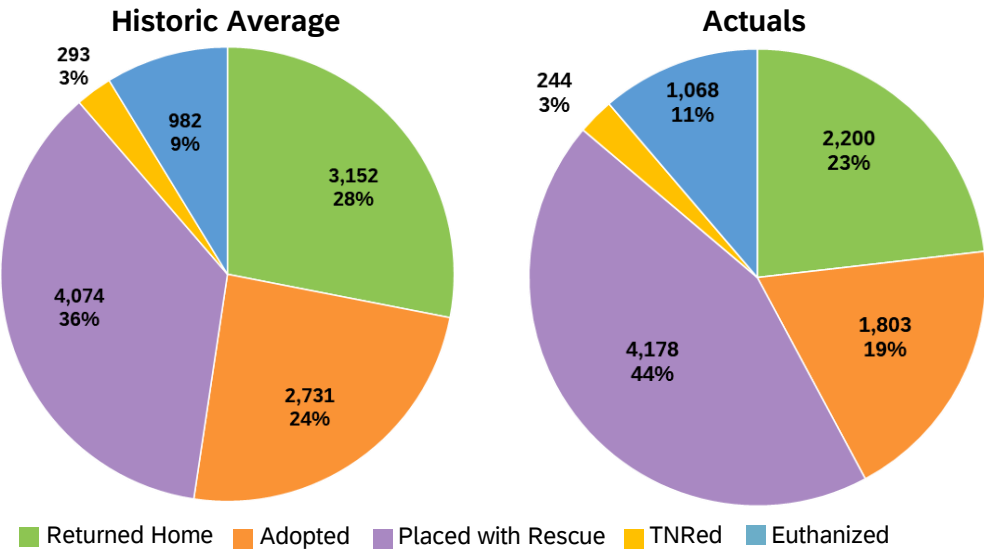

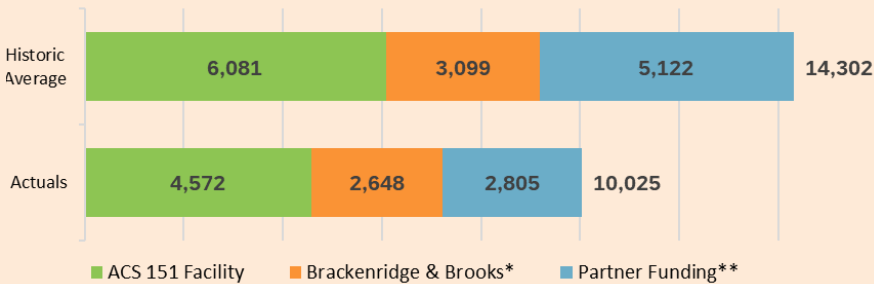

## SPAY/NEUTER SURGERIES

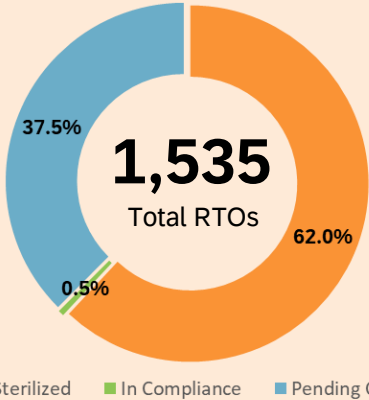

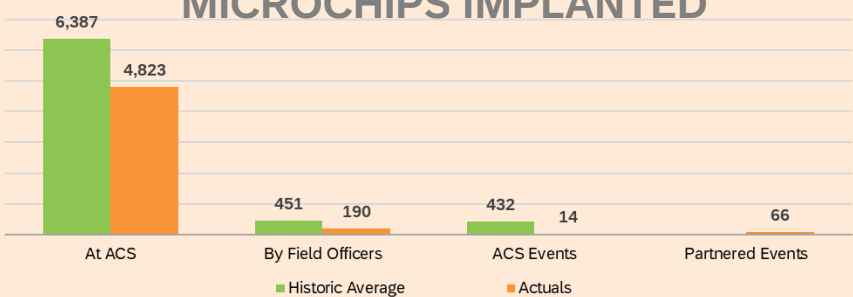
Sterilization agreement compliance rates for animals RTOed. Total RTOs does not include diversions.
