This signage should be placed where public and staff will see immediately upon entry, and throughout the kennel area.  2) Back sidewalk had numerous tripping hazards including a hose that was crossing the walk multiple times, and clean crates that had fallene over and were laying on the ground blocking the walk. This area is easily accessible to the public so much be kept safe and clear (for staff, too).

<sup>1)</sup> Very concerned that there is a sign in the adult dog kennel area requiring staff to spray shoes with Rescue disinfectant before leaving the kennel, but staff admit that this is not being done. Rescue bottles were not there where they were supposed to be. Recommend either d/c this policy if it's not necessary; or, staff and public need to adhere to the policy if it IS necessary. It is not a good practice to post policies that are not being followed. This fosters an attitude of dismissing signage directions.

<sup>3)</sup> Classical music playing in adult kennel area is an excellent touch. Pleasant for the dogs and the public.
