The following high-profile project has completed the solicitation process. This item is presented to the Audit and Accountability Committee for review prior to the full City Council for consideration.

**On-Call Professional Services for Real Estate Appraisal Services** - Public Works Department issued a Request for Qualifications (RFQ) for firms to provide on-call or as needed real estate appraisal services throughout Bexar County, Texas.
