# **SUBJECT:**

Pre-Solicitation High Profile Item for Pressure Washing Services

# **SUMMARY:**

The Aviation Department is soliciting proposals for a contractor to provide commercial pressure washing services for the San Antonio International Airport (SAIA). Services include removal of contaminants such as surface oxidation, black algae, mold, dirt, grime, food, beverage spills, grease, oil, gum, and tar from concrete, pavers, stone, and other hard surfaces utilizing a non-destructive process for each type of flat or vertical surface material.

Areas to be serviced include, but are not limited, to SAIA Terminal A and Terminal B buildings and associated passenger landing areas; Long Term and Short Term Parking Garages; Ground Transportation Center; bus stops, and enclosures located on SAIA property; parking booth structures and surrounding curbs and islands; and the Parking Administration Building.
