#### **SUBJECT:**

Pavement Condition Assessment Services of City's Street Network

### **SUMMARY:**

The Public Works Department is seeking proposals from qualified firms interested in providing professional asset management services for pavement condition assessment. The City requests services include, but not limited to, providing automated Pavement Condition Index (PCI) following the American Society for Testing and Materials (ASTM) Standard D6433 and a comprehensive Pavement Condition Summary Report for approximately 4,224 centerline miles of paved streets in the City. Currently, data collected in 2019 resides in the City's Asset Management Software (AMS).

New data collected will be used with the City's AMS. The AMS is used for planning purposes across the City to include asset inventory management, budgeting and tracking of maintenance activities. In addition, the current system allows for updating the Pavement Condition Index (PCI) scores after scheduled maintenance or repairs of a street segment has been completed.

Accordingly, data collected through this effort will need to be integrated with the current system.
