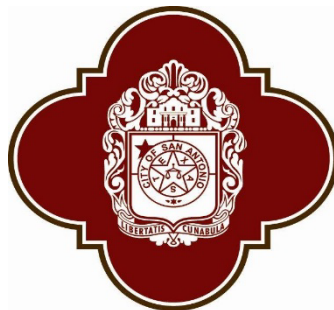

SUBJECT:

Consideration of one (1) At-large appointment and (3) reappointments to the Building Standards Board.

SUMMARY:

The Planning & Community Development Council Committee has been provided information and background regarding one (1) applicant to fill the Professional Property Manager At-Large vacant seat and (3) reappointments on the Building Standards Board. The individuals will serve the remainder of the unexpired terms of office to expire on May 31, 2025.

BACKGROUND INFORMATION:

The Building Standards Board is a citizen-based board and has 14 members appointed by City Council: two panels of seven members each. The Board is appointed by the City Council with each City Council member appointing their own representative to the board. Board composition is comprised of the following categories: Architect, Engineer, General Contractor, Social Worker, Health Care Professional, Retired individual (over the age of 64) and Veteran of the United States Military. A professional property manager may be substituted for one general contractor and/or one social worker. Members serve overlapping two-year terms and there is no limit on the number of terms that may be served.

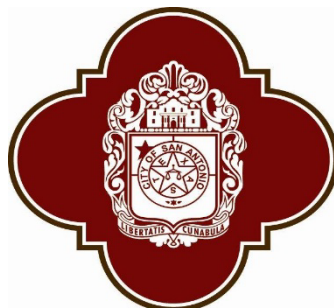
