New Business

1. **MAJOR THOROUGHFARE PLAN AMENDMENT:** Consideration of a request to amend the Major Thoroughfare Plan, a component of the City of San Antonio Master Plan, by removing a proposed segment of Senior Road, a Secondary Arterial Type A requiring 86' feet of right-of way, at the south end portion of the proposed arterial. Staff recommends approval. (Debora Gonzalez, Senior Transportation Planner, (210) 207-8085, debora.gonzalez@sanantonio.gov, Transportation Department)

Debora Gonzalez, Senior Transportation Planner, presented item and recommended approval.

Gustavo Gutierrez, project engineer, stated the purpose of this request is to remove a proposed segment of Senior Road which currently dissect his client's property. He stated his client needs to plat her property in order to get electricity, water and septic services. However, in doing so, she would have to relinquish a large portion of her property, 86-foot right-of-way. Therefore, they are requesting this portion of the be removed from the major thoroughfare plan.

Monrovia Goodlin, applicant, stated she has lived on the property for 6 years. She is needing to plat for services for her farm animals. As mentioned by her engineer, she would have to give up a large portion of her property to plat. She is seeking a form of exemption from relinquish a portion of her property.

A motion was made by Committee Member Dessouky to select the alternative road to the one that proposed to be removed.

Committee Member Sherrill made a motion to realign it along to the existing property line with the entire thoroughfare inside the current property. Chair Peck clarified it is on the west side of the property line that divides the unplatted portion of Lot 1 and Lot 2. The motion was seconded by Committee Member Dessouky
