Settlement Agreement

SUMMARY:

This Ordinance authorizes a settlement of a state lawsuit styled Anthony Corona v. City of San Antonio, in the 408th Judicial District Court, Bexar County, Texas, Cause No. 2021-CI-09837 for the amount of \$140,000.00.

BACKGROUND INFORMATION:

On June 21, 2020, an SAPD officer drove around a barricade set up for installation of Google Fiber in West San Antonio. The vehicle ran over a cable that Plaintiff was working with, causing Plaintiff to be flipped in the air. Plaintiff suffered injuries to his back and neck requiring medical treatment.

The parties have agreed to settle Anthony Corona's claims for \$140,000.00 subject to City Council approval. The funds are available from the FY 2024 Liability Fund Adopted Budget.

Trial of this case has been postponed pending consideration of this settlement.

ISSUE:

Settlements over \$100,000 require City Council approval.

ALTERNATIVES:

If this settlement agreement is not approved by the City Council, the case will proceed to trial. It is in the best interest of the City to settle this matter to avoid the uncertainty and risks associated with litigation.

FISCAL IMPACT:

If the settlement is approved, \$140,000.00 will be paid by a check made payable to Anthony Corona, his attorneys of record and any lienholders as directed by the City Attorney's Office from the Self Insurance Fund.

RECOMMENDATION:

Staff recommends approval of this Ordinance.

ORDINANCE

APPROVING THE SETTLEMENT OF LITIGATION STYLED *ANTHONY CORONA V. CITY OF SAN ANTONIO*; CAUSE NO. 2021-CI-09837, IN A TOTAL AMOUNT OF \$140,000.00.

* * * * *

WHEREAS, on June 21, 2020, an SAPD officer drove around a barricade set up for installation of Google Fiber in West San Antonio, driving over a cable held by Anthony Corona; and

WHEREAS, as a result of this incident, Mr Corona alleges he suffered injuries and incurred medical expenses, both past and future, as well as pain and suffering, and has filed suit seeking to recover damages; and

WHEREAS, although the City of San Antonio has vigorously contested this matter, it is in the City's best interest to settle this matter to avoid the uncertainties and risks associated with further litigation; and

WHEREAS, the parties have reached an agreement to settle the claims of Anthony Corona in the amount of \$140,000 payable from the Self-Insurance Liability Fund subject to City Council approval; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The amount of \$140,000.00 is authorized to be paid from Fund 75001000, Insurance Reserve Fund, General Ledger 5402530 General Liability Claims, Cost Center 7509020004 Risk Management-Liability, and is authorized to be made payable as to Mr. Anthony Corona and his attorneys of record, Thomas J. Henry Injury Lawyers, as directed by the City Attorney or his designee.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
