# Project and Solicitation



The Development Services Department issued a solicitation to select up to 9 contractors for clearing and securing of structures on an “as needed” basis to:

- Mow and clear premises
  - Mow grass and weeds
  - Remove brush, rubbish, rocks, bricks and trash
  - Paint over graffiti
- Clear debris

- Request for Proposals (RFP)

## Proposed Term

- 1 year with 4, 1-year options

## Estimated Value

- \$640,000 annually
- \$3.2 million total
