The Public Works Department issued a Request for Competitive Sealed Proposals (RFCSP) for construction services of the Fire Station #53 Replacement. This project located in Council District 3 at 14102 Donop Road and is funded with Certificates of Obligation. The fire station will include an Emergency Medical Services (EMS) bay, sleeping quarters for the assigned crew, apparatus bays, support equipment bunker, gym, kitchen, and common area.
