THE MCSW SHALL SEEK: “TO FOSTER A CLOSER RELATIONSHIP AND A FULLER EXCHANGE OF IDEAS BETWEEN WOMEN OF RESPECTIVE DISTRICTS AND CITY COUNCIL MEMBERS; TO FURTHER THE EQUAL LEGAL, SOCIAL, POLITICAL, ECONOMIC, AND EDUCATIONAL OPPORTUNITY AND ADVANCEMENT OF ALL WOMEN AND MEN; TO ELIMINATE DISCRIMINATION ON THE BASIS OF SEX IN ALL PHASES OF AMERICAN SOCIETY; TO PROMOTE THE DISSEMINATION OF INFORMATION ON EMPLOYMENT OPPORTUNITIES FOR WOMEN IN THE PUBLIC SECTORS, AND TO PROVIDE COUNSEL WHEN AND IF NECESSARY; TO ENCOURAGE WOMEN TO ASSUME INITIATIVE AND ACCEPT THEIR RESPONSIBILITY IN THE REMOVAL OF LEGAL AND OTHER BARRIERS TO THE REALIZATION OF THEIR BASIC HUMAN RIGHTS.”
