This comment is about the Train for SA program. The pilot of which is novel with the intent of placing prospective talent in information technology with their certifications to match the needs of a growing city. We're currently in a CompTIA training course that promises \$450/wk (\$15/hr.; M-Th, 30hrs./wk) with guaranteed job placement. My previous experience is a decade in IT, software, and computer sciences with my last job being with USAA, my hold up is the fact I do not have these certificates. After beginning this program with the IT Fundamentals (ITF+), I was informed this is not employment meaning it compromised what I reported on income to SNAP (since it is not taxable income) and Medicaid, then after finishing that course after the logistics hang ups like 3 week delay in payment, getting \$360/wk., I find out that we have to finish these courses which do not apply in any way towards the certification, to then "get a voucher" for the actual test then immediately move to the next with no audit on that single try or follow up on if or where we maybe deficit for this certification test. Meanwhile we haven't received said voucher to this day. The pace, the lack of interfacing or networking with people in the industry, the voucher system, and the fact we're facing in my class right now people not receiving text books, there are so many logistics issues that do not feel they best serve our needs as people aspiring to move up in IT in SA.
