# Discussion and possible action for appointment and engagement of Bond Counsel

# Summary:

The SA Housing Trust issued an RFQ for Legal Services including General Partnership Counsel and Bond Counsel for the PFC and Finance Corporation. Proposals were due in July 2021 in anticipation of the Governance Realignment occurring in 2021.

**Bond Counsel** provides legal needs to authorize, issue, sell, and deliver private activity bonds associated with our corporations. They render an objective legal opinion with respect to validity of any obligations issued while securing necessary City Council, Texas Bond Review Board, Texas Department of Housing and Community Affairs, Texas Attorney General, and other approvals necessary for bond related transactions. Bond Counsel also coordinates with other transactional counsel, rating agencies, insurance providers, tax credit syndicators, etc... in connection with bond related transactions including managing the TEFRA hearing process and other necessary hearings related to bond transactions. SAHT received the following responsive proposals for Bond Counsel:

- Adam C. Harden Locke Lord, LLP
- James Plummer Bracewell, LLP

An evaluation team consisting of highly regarded attorney's and SAHT staff met on several occasions from November 2021 through January 2022 to discuss the responsive proposals, develop a shortlist, and provide a recommendation. The team reviewed based on the respondent's ability to carry out scope of legal services, their specific record and experience, and professional qualifications. The evaluation committee which met in December 2021 recommended two firms Bracewell and Lock Lord.

The *Governance and Policy Committee* met on March 15, 2022, to review the evaluation team's recommendation. After consultation with the Executive Director and General Counsel, the Committee is recommending the board to authorize the Pete Alanis, Executive Director, to negotiate and execute an engagement letter with Bracewell to serve as Bond Counsel to the Finance Corporation. Committee also recommends issuing another RFQ for additional capacity.

### **RESOLUTION NO. FC22-0323-05**

A RESOLUTION APPROVING, AFFIRMING AND RATIFYING THE CREATION OF AN AD-HOC SUSTAINABILITY AND UNIVERSAL DESIGN COMMITTEE FOR THE SPECIFIC TASK OF DESIGN, ACCESSIBILITY, INCLUSION, AND SUSTAINABILITY; AND SETTING AN EFFECTIVE DATE

WHEREAS, to implement the changes to the governance structure and operations of the San Antonio Housing Trust Finance Corporation ("SAHTFC"), the Board of Directors adopted amendments to SAHTFC's Certificate of Formation and Bylaws of the Corporation on May 26, 2021; and

WHEREAS, the City of San Antonio ("City") determined that the recommendation to restructure the composition of the Board of Directors of the SAHTFC to better balance the collective skills, interests, and authorities of the Board and thus promote unified policy development, perspective in decision making, and enhancement of transparency is wise, expedient, and necessary; and

WHEREAS, pursuant to Section 303.024 of the Texas Local Government Code and the SAHTFC Bylaws, the City must authorize and approve amendments to the Certificate of Formation and Bylaws of the SAHTFC and approve the form of the amendments and such were approved on June 10, 2021; and

WHEREAS, Section 2.6 Committees of the Board, of the Amended and Restated Bylaws of the SAHTFC, state that the Board President shall have the ability to create ad-hoc committees as needed and for specific tasks to exercise such authority, as approved by resolution of the Directors; and

**WHEREAS**, the Board President of the SAHTFC created the Sustainability and Universal Design Committee for the specific tasks of design, accessibility, inclusion, and sustainability for all SAHTFC projects on February 23, 2022 at the Board Meeting; and

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE SAN ANTONIO HOUSING TRUST FINANCE CORPORATION, THAT:

Section 1. This resolution hereby affirms and ratifies that the Sustainability and Universal Design Committee is established for the SAHTFC specifically for the tasks of identifying and developing recommendations and concepts for design, accessibility, inclusion, and sustainability for all SAHTFC projects or as otherwise directed by the Board of the SAHTFC.
