The City Council convened a regular meeting in the Norma S. Rodriguez Council Chamber in the Municipal Plaza Building beginning at 9:24 AM. Interim City Clerk Debbie Racca-Sittre took the Roll Call noting a quorum with the following Council Members present:

Mayor Nirenberg recognized the death of local leader and philanthropist Helen "Helenita" Kleberg Page 1 of 13

Groves and Councilmember Rocha Garcia read a short biography.

Mayor Nirenberg recognized attendees from the Naval War College's Naval Command College graduating class of 2022 representing 49 nations. City Attorney Andy Segovia and Councilmember Pelaez congratulated the class.

Mayor Nirenberg proclaimed May 2022 as National Bike Month and May 20, 2022 as National Bike to Work Day. Representatives from B Cycle, the bicycle community and bicycle planners provided information about events and spoke in support of bike programs and safety.

Councilmembers Bravo, Sandoval, Pelaez, Castillo and Viagran spoke in support of the bicycle community and National Bike Month.

Mayor Nirenberg recognized Economic Development Week, the work of the Economic Development Department and many local organizations and read a Proclamation for the week of May 9, 2022.

Councilmembers Rocha Garcia, Cabello Havrda and Sandoval recognized May as Mental Health Month. Councilmember Cabello Havrda spoke regarding the work of San Antonio Police Department and Chief William McManus recognized members of the Mental Health Unit. Councilmember Rocha Garcia recognized the non-profit Form Communities – SA Clubhouse who spoke in support of mental health awareness and provided information on their programs. Councilmember Sandoval recognized the work of the San Antonio Youth Commission and the City's focus on trauma informed care.

Councilmember Sandoval recognized a team of Harvard Master of Business Administration (MBA) students that were participating in the field immersion program to work on a project titled Texas Property Assessed Clean Energy (PACE) in San Antonio during the summer.

Councilmember Pelaez recognized the success of the 12th annual Corona Paella Challenge and the 10th annual High School Paella Challenge and local high school students from MacArthur High School that won 1st place, Brackenridge High School that won 2nd place and Somerset High School that won 3rd place.

Councilmember Rocha Garcia noted that she was a board member of Kitchen Campus program, spoke in support of the program, the Paella Challenge and culinary arts in San Antonio. Councilmember Viagran recognized Chef Johnny Hernandez, lead of the Paella Challenge. Councilmember Castillo recognized Paella Challenge participants from Council District 5 from Memorial, Lanier, and Brackenridge High Schools. Councilmember Perry recognized that MacArthur High School won 2 years in a row. Chef Johnny Hernandez announced that the first and second place winners would go to New York for another competition.

Councilmember Viagran recognized May as Military Appreciation Month and the local District 3 VFW Posts 926, 837, 4815, and Commander Roger Gomez. Councilmember Viagran also recognized various organizations that assist Veterans and their beneficiaries.

Councilmember Castillo thanked the Solid Waste Management Department and Haven for Hope Ambassadors for last week's cleanup in the Quintana neighborhood.

ACTION ITEMS FOR STAFF BRIEFING

3. Ordinance authorizing the execution of a Collective Bargaining Agreement with the San Antonio Police Officers' Association for a period to commence upon City Council approval to September 30, 2026. [Erik Walsh, City Manager]

Deputy City Manager Maria Villagomez recognized the negotiation team from both the San Antonio Police Officer's Association (SAPOA) and the City of San Antonio and thanked the City Manager, Police Chief and City Attorney for their efforts. Deputy City Manager Villagomez provided an overview of the statutory parameters of employment for San Antonio Police Officers and the Collective Bargaining Agreement. Deputy City Manager Villagomez provided a history of the contract negotiations and outlined the City's priorities included in the agreement as follows: rebalance the disciplinary process, provide competitive wages and benefits for Police Officers and maintain spending below 66% of the total City's General Fund Budget.

City Manager Erik Walsh commented that all three objectives were met and thanked the negotiation teams for their professional approach.

Mayor Nirenberg recognized SAPOA President Danny Diaz who spoke in support of the collective bargaining agreement on behalf of the members of SAPOA.

DISCUSSION:

Mayor Nirenberg opened the discussion by thanking the negotiating teams and commented that the agreement was negotiated in a good-faith transparent manner. Mayor Nirenberg expressed confidence that the negotiated agreement related to disciplinary action would put the City in a good position and noted the 66% budget cap for public safety expenditures from the total City's General Fund.

Councilmember Cabello Havrda, Chair of the Public Safety Committee, spoke in support of the Item and mentioned that the added training hours would benefit the community as mental health was important for residents and our first responders.

Councilmember Pelaez spoke in support of the Item and noted that all negotiations inherently included compromises, and the agreement was the best that could be reached at this time to keep emergency response times low.

Councilmember Bravo stated that he had committed to his residents to reform the SAPD and noted that though the contract met some of his requirements, it did not meet all of them, and he did not support the Item.

Councilmember Sandoval thanked the City negotiating team for making the process transparent and less divisive. Councilmember Sandoval said that her residents wanted to feel safe, particularly for mental health calls and they wanted accountability. Councilmember Sandoval noted that this contract met those guidelines and suggested that any additional request would sacrifice the progress already made under the good-faith negotiations, so she supported the Item.

Councilmember Sandoval requested clarification on whether the City could create an advisory board for Police Services. First Assistant City Attorney Liz Provencio and City Manager Walsh both stated that an advisory board could be created so long as it did not interfere with any authority statutorily granted to the Chief or to the rights of the officers under the collective bargaining agreement.

Councilmember Courage noted that having been a former Military Police Officer, he brought a unique perspective and commented that the work of a police officer was dangerous.

Councilmember Courage stated that the contract was a negotiation in good faith, and it did not address all of his concerns, but it was a good faith negotiation and he supported the Item but recommended continued work with police officers and the community to create a better police force.

Councilmember Rocha Garcia requested more information on the leadership training component and new supervisor mentorship component of the contract. Chief McManus provided a description of the training and mentorship programs. Councilmember Rocha Garcia stated that the contract rebalanced the disciplinary process and that an arbitrator could not overturn the Chief's decision. Councilmember Rocha Garcia stated that she would support the Item.

Councilmember Castillo stated that the contract fell short on some items and suggested that the public commenters should continue to voice their concerns. Councilmember Castillo requested that advance mental health peace officer training and crisis intervention training be made available to officers. Deputy City Manager Villagomez confirmed that these were available. Councilmember Castillo noted State laws related to keeping complaints about officers confidential and recommended including this in the next State legislative initiative so San Antonio could advocate for transparency. Councilmember Castillo recommended collective bargaining agreement terms of two to three years instead of the five-year agreement with an eight-year evergreen clause.

Councilmember Perry spoke in support of the negotiation and the Item and noted that in a negotiation, no one could expect to get 100% of what they wanted. Councilmember Perry commented that the contract was negotiated professionally, sincerely and in good faith.

Councilmember McKee-Rodriguez commented that the efforts of the community to demand better

disciplinary terms had paid off with the resulting contract but maintained that the contract did not go far enough in addressing police misconduct and included too much funding that risked crowding out other areas of the budget. Councilmember McKee-Rodriguez requested information on legislative items. Provencio noted that three of the five initiatives got out of committee at the State Legislature but none passed. Councilmember McKee-Rodriguez stated that there should be more representation on the CARB from East Side, South Side and West Side as it was heavily weighted to the North Side.

Councilmember Viagran commented that the collective bargaining agreement was a labor agreement and noted that prior to having an agreement, there were no women on the police force and there was a height requirement that restricted short Latino men from becoming Police Officers. Councilmember Viagran stated that resident surveys indicated that residents wanted more patrols and a substation in their area. Councilmember Viagran suggested that a vote against the contract was a vote to defund the police.

Councilmember Pelaez mentioned that the new leadership in SAPOA have made a large difference in the negotiations and the final agreement. Councilmember Peleaz commented that the City Council was bound by the law.

Councilmember Castillo requested clarification on House Bill 1900 which was explained by Deputy City Manager Villagomez as a limit on reducing funding for police.

Councilmember McKee-Rodriguez stated that reforming the CARB, using paid leave for police on discipline leave, evergreen clause and pay increases did not reduce the budget and his comments were related to accountability.

Councilmember Bravo stated that he wanted to promote public safety and would continue to work on solutions.

Mayor Nirenberg thanked the community and negotiating teams and closed by stating that the contract was fiscally responsible, transparent and increased accountability.
