The Parks and Recreation Board will hold its regular meeting in the City Tower Concourse Conference Room A located at 100 W. Houston, San Antonio, Texas, 78205 beginning at 5:30 PM. The City Tower Concourse Level can be accessed utilizing the City Tower Parking Garage elevators. Access to these elevators is available at the street level on either the Flores Street or Main Street sides of the facility. If a visitor parks within the City Tower Parking Garage, any of the elevators within the parking structure will allow access directly to the Concourse Level. There is a Security Officer detail in place, at the Concourse Level elevators, to conduct the needed security screening and visitor check in. Members of the public may provide comment on any agenda item, consistent with procedural rules governing the Board meetings and state law. Public comments may be provided as follows:

1. In-Person: Sign up to speak in-person prior to the start of the meeting via the Public Comments SignUp sheet available in the meeting room location. Each speaker will be allowed a maximum of three minutes.
2. Written: Provide written comments (up to 300 words maximum) via email by 4:00 p.m. on the date of the meeting to Ryan.Harrison@sanantonio.gov. Please include full name and address. General comments unrelated to specific agenda items will be read during the Public Comments portion of the agenda.
