1. Invocation

The invocation was delivered by Elder Peter Onofre of New Life Christian Center, guest of Councilmember Rocha Garcia, Council District 4.

2. Pledge of Allegiance

Mayor Nirenberg led the assembly in the Pledge of Allegiance.

Councilmember Viagran recognized the work of the Legacy Leadership Institute.

Councilmember Rocha Garcia recognized the service of David Zammiello, President and Chief Executive Officer of Project Quest.

Mayor Nirenberg presented official congratulations to Zammiello for his retirement.

Councilmember Castillo recognized the San Antonio Fire Department for their work fighting a fire at a metal recycling facility in Council District 5.

4. Ordinance approving the Memorial Street Name Designation of East and West Cevallos to reflect Emma Tenayuca Memorial Way, between IH-35 and Probandt Street. [Roderick Sanchez, Assistance City Manager; Michael Shannon, Director, Development Services]

Director of Development Services Michael Shannon presented an overview of the Item noting that Councilmember Castillo had submitted a Council Consideration Request (CCR) for the street name designation. Shannon provided an overview of the timeline and fiscal impact to the designation which was under \$5,000. Shannon clarified that no addresses would be changed along Cevallos Street because this was a memorial designation.

Councilmember Castillo spoke in support of the designation and provided a bio on Emma Tenayuca and thanked organized labor for their efforts to make the lives of workers better. Castillo announced an upcoming celebration of the 85th anniversary of the Pecan Sheller's Strike at Cassiano Park. Councilmember Castillo invited Sarah Zenaida Gould, Director of the Mexican American Civil Rights Institute (MACRI) and members of the Tenayuca family to speak in support of the designation. Councilmember Castillo also thanked educators at UTSA for teaching their students about the work of Tenayuca.

Mayor Nirenberg spoke in support of the designation and the difficult work of Tenayuca, a young Latina fighting for the rights of minority and women workers at a time when white men were in power. Mayor Nirenberg commented that it was time to recognize the significant contributions of Mexican Americans in San Antonio.

Councilmember Viagran spoke in support of the Item recalling that she had migrant workers and pecan shellers in her family. She also thanked Councilmember Castillo for bringing the designation forward.

Councilmember Cabello Havrda thanked the MACRI and Tenayuca family for being at the meeting and working toward the recognition of the contributions of Tenayuca and Mexican Americans. She also thanked Councilmember Castillo and the Mayor for bringing the designation forward as Tenayuca's work paved the way for many Latinos in San Antonio.

Councilmember Sandoval spoke in support of the Item and stated that she hoped this was the beginning of more education related to worker's rights through the MACRI and others.

Councilmember McKee-Rodriguez commented that Emma Tenayuca was one of the most historically important individuals in San Antonio and he was pleased to support Councilmember Castillo's CCR designating the street in her honor.

Councilmember Rocha Garcia spoke in support of the MACRI and the designation. She also thanked Councilmember Castillo and Mayor Nirenberg for bringing the designation forward.

Councilmember Courage spoke in support of the designation acknowledging the commitment of the City Council to better represent the interests of those who had gone unrecognized.

Councilmember Perry thanked Councilmember Castillo for bringing the Item forward to recognize the work of Tenayuca.

5. Ordinance accepting the resignation of Councilmember Ana Sandoval, District 7, and initiating procedures to select a temporary Councilmember. [Debbie Racca-Sittre, City Clerk]

Councilmember Sandoval thanked the Council District 7 community, council colleagues, the staff, her family and friends for their support over the past five and a half years. Councilmember Sandoval stated that she wanted to be a Councilmember so she could help improve the community's infrastructure, health, energy sustainability, and improve people's lives.

Mayor Nirenberg recognized the accomplishments of Councilmember Sandoval including her dedication to equity, safety with all modes of transportation, Resiliency Environmental Sustainability Fund, Climate Action Plan, and expressed gratitude for her service.

Councilmember Cabello Havrda thanked Councilmember Sandoval for the time and dedication she gave to her residents, the climate initiatives, health, equity, and other initiatives that she championed.

Councilmember Rocha Garcia commented that she was inducted into City Council as the first majority-woman City Council alongside Councilmember Sandoval and noted that both of their parents

were Spanish speakers which led them to collaborate on language accessibility issues. Councilmember Rocha Garcia recognized Councilmember Sandoval for her work on health, equity, and transportation safety.

Councilmember McKee-Rodriguez thanked Councilmember Sandoval for her leadership and friendship. He thanked her for chairing the Community, Health, Environment and Culture Committee and pushing for more community engagement by pushing for policies for the City to provide transportation and parking for the public.

Councilmember Pelaez stated that the City Council was losing a zealous fighter for the rights of residents.

Councilmember Viagran commented that being a woman on the dais was a challenge and noted that Councilmember Sandoval had been a strong leader and supporter of climate equity.

Councilmember Courage recalled that in 2017 there were six new Councilmembers and the mayor moved up from Council District 8 and Councilmember Sandoval was one of them. Councilmember Courage stated that he appreciated her counsel and collaboration.

Councilmember Perry acknowledged that he often disagreed with Councilmember Sandoval on positions but that there was mutual respect and professionalism that he enjoyed. Councilmember Perry thanked Councilmember Sandoval for her work on the City Council and her commitment to her residents.

Councilmember Castillo joked that she wanted to delay the Item to 2025, however, she understood and respected the decision. Councilmember Castillo thanked Councilmember Sandoval for collaborating on drainage issues, heat illnesses for workers and her work on equity and the environment.

Councilmember Bravo listed numerous actions that Councilmember Sandoval took to make our government more accessible. Councilmember Bravo spoke of Councilmember Sandoval's efforts in streamlining Committee meetings.

PUBLIC COMMENT

L. Dan Eldredge, attorney representing property owner Vince Cantu spoke in opposition to the Item.

The following persons spoke in support of the Item: Pete Broderick, immediate past chair of the Board of Directors for Centro San Antonio; Forrest Byas, member of the Alamo Citizen Advisory Commission; Marialyn Barnard former chair of the Alamo Museum Planning Committee; Phillip Bakke, Alamo Redevelopment Project Construction Manager; Patricia Mota and Diane Baird-Barger descendants of Alamo defender Toribio Losoya; Hope Andrade, Chair of the Alamo Management Committee; Marco Barros, management consultant; Kate Rogers, Executive Director of the Alamo Trust; Dave Peterson, Interim Chief Executive Officer of the San Antonio Chamber of Commerce; Paul Covey and Kevin Covey, local developers; and Cheryl Wyatt, local resident who had attended the 1960 sit-in at the Woolworth's Building.

DISCUSSION:

Councilmember Pelaez asked the City Attorney if there had been any negotiations or offers made by the State of Texas and whether the condemnation was racially motivated. Segovia stated that there had been offers made with no racial bias. Councilmember Pelaez noted that the project was intended to tell the Alamo stories of all races and clarified that the use of eminent domain still required negotiations and fair offers.

Councilmember Cabello Havrda confirmed that negotiations needed to continue.

Councilmember Rocha Garcia asked about the difference between going forward today or getting an extension. Segovia stated that any delay could delay the project. Councilmember Rocha Garcia acknowledged Segovia's statement and thanked those who came to speak and the members of the

Alamo Trust for their work.

Councilmember Viagran thanked the Losoya descendants for coming to speak as she was also a descendant of Losoya. She commented that the Alamo project needed to reflect all of the stories including the Alamo, Tejano, women, and the civil rights sit-in.

Councilmember Perry recalled that the original Alamo Plan was presented six years ago which he opposed but noted that changes had been made to the design that changed his mind. Councilmember Perry was disappointed that a deal had not been made for the property without the use of eminent domain, but he supported the Item.

Councilmember Castillo noted that she supported property rights and recommended that the offer from the State considered the additional revenues that the Alamo would bring for which the owner would not benefit. Councilmember Castillo asked the City Attorney how the City notified the property owner of the Item. Sandoval stated that the City posted the Item and Rogers reported that the Alamo Trust notified the property owner. Councilmember Castillo supported a two-week postponement as requested by the property owner.

Councilmember McKee-Rodriguez stated that he had planned to vote against the Item but noted that so many residents came to support the project.

Councilmember McKee-Rodriguez moved to delay the Item until February 9, 2023. Councilmember Castillo seconded the motion. The motion failed by the following vote:

Mayor Nirenberg noted that the Alamo was a historical icon of our city. Mayor Nirenberg clarified that the Item was to authorize the use of imminent domain so that negotiations could be accelerated. Mayor Nirenberg stated that there was a triparty agreement between the State, the City and the Alamo Trust and asked that both the State and the owner negotiate in good faith regarding the property.

Councilmember Viagran asked Brenda Pacheco, member of the Alamo Committee to speak. Pacheco stated that it was important that all stories were told and provided historical background on the Missions and the Alamo and how Native American and Mexican Americans were impacted. Pacheco urged City Council to approve the Item for the greater good of San Antonio. Councilmember Viagran supported negotiations and a settlement to pay the owner fair market value for his property.
