The City Council convened a regular meeting in the Norma S. Rodriguez Council Chamber in the Municipal Plaza Building beginning at 9:03 AM. City Clerk Debbie Racca-Sittre took the Roll Call noting a quorum with the following Council Members present:

#### **PROCEDURAL**

#### 1. Invocation

The invocation was delivered by Pastor David Cameron of the The Refuge Church, guest of Councilmember Viagran, Council District 3

#### 2. Pledge of Allegiance

Mayor Nirenberg led the assembly in the Pledge of Allegiance.

#### POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg invited Deborah Omowale Jarmon, Director of the San Antonio African American Community Archives and Museum, to speak in honor of Black History Month. Monica Love sang the Black National Anthem.

Councilmember Viagran read a proclamation in honor of the 74<sup>th</sup> annual San Antonio Stock Show and Rodeo and invited ambassadors of the San Antonio Stock Show and Rodeo to kickoff the 2023 rodeo season.

Councilmember Bravo recognized the Monte Vista Historic Homeowner's Association. Mayor Nirenberg provided a distinguished congratulations on the celebration of 50 years of the historical association.

Councilmember Pelaez recognized Dr. Ralph Defronzo, Professor of Medicine and Chief of the Diabetes Division at the University of Texas Health Science Center at San Antonio (UTHSCSA) and the Deputy Director of the Texas Diabetes Institute, who had provided significant contributions to diabetes science. Mayor Nirenberg read a citation congratulating Dr. Defronzo for winning the 2023 Prince Mahidol Award.

Councilmember Castillo recognized the work of John William Gauna Jr. who left the Veteran's Advisory Commission to work for the Department of Human Services.

Councilmember Perry recognized retired Army Lt. Col Hazel Zachar who was celebrating her 101<sup>st</sup> birthday.

#### **ACTION ITEMS FOR STAFF BRIEFING**

#### 2023-02-02-0043

3. Ordinance approving the American Rescue Plan Act (ARPA) - State and Local Fiscal Recovery Fund (SLFRF) award recommendations for Non-Profit Social Services (Phase II), Senior Services, Youth Services and Mental Health Services combined competitive solicitation in the amount of \$40,150,000; and authorizing the negotiation and execution of contracts and amendments. [Lori Houston, Assistant City Manager; Melody Woosley, Director, Human Services & Erik Walsh, City Manager; Claude Jacob, Director, Health]

City Manager Erik Walsh noted that the staff recommendation had changed since the B session last week and now staff recommended the return of the remaining \$3.7 million in unallocated funding to the Council Committees for discussion and recommendations related to potential reprogramming.

Jessica Dovalina, Assistant Department of Human Services (DHS) Director, provided an overview of the Item including background on the ARPA Spending Framework Plan, Request for Proposals (RFP) process, scoring criteria, evaluation panel, and timeline. Dovalina outlined the target service areas, provided a chart of funding by council district, listed the funding recommendations for non-profit social services, youth services and senior services.

Jessie Higgins, Chief Mental Health Officer, provided an overview of the Mental Health Grant recommendations. Higgins outlined the performance measures and a dashboard that would track the progress of the grants.

Angela White, Child Advocates of San Antonio; Ada Saenz, Boys & Girls Clubs of San Antonio; Asia Ciaravino, President and CEO of the Children's Shelter; Lauren Ferrero, Board Chair of the Children's Bereavement Center of San Antonio; Lea Rosenauer, President and CEO of Girls, Inc; Dawn White-Fosdick, President and CEO of Christian Assistance Ministries; Ashley O'Leary, representing Corazon Ministries; Evita Morin, CEO of Rise Recovery; Robert Salcido, Executive Director (ED) of Pride Center San Antonio; Cliff Zintgraff, Chief Learning Officer for San Antonio Museum of Science and Technology; Bill Neely, San Antonio Community Resource Directory; Bennie Price and Rose Williams ED with Big Momma's Safe House; Sandra Morales, ED House of Neighborly Service; Leonard Rodriguez, Senior Director and Edward Benavides, Vice President Adult Behavioral Health at The Center for Health Care Services; Peggy Eighmy with UTSA Bexar County Fostering Educational Success; Mercedes Bristol, ED Texas Grandparents Raising Grandchildren; Mario Obledo, Jr. Chief Government & Public Affairs Officer with San Antonio Food Bank; Brenda Schmachtenberger, ED San Antonio Oasis; Ginny Funk, Director of Programs Alzheimer's Disease and Related Disorders; Abigail Moore, ED of the San Antonio Council on Alcohol and Drug Awareness; and Cynthia Watson, President & CEO of the San Antonio Lighthouse for the Blind; spoke in support of the Item and funding for their agencies.

Kayla Carter, Founder and Chief Executive Officer (CEO) of the non-profit For Her; Charles Sattiewhite with San Antonio Rising Stars; Kim Abernethy, CEO of Child Safe; Denise Barkhurst, President and CEO of Big Brothers & Big Sisters; Dr. Amanda Villareal, Ride Connect San Antonio requested funding for their agencies as they were not included in the staff recommendations.

Jack Finger spoke in opposition to the Item, particularly funding for Pride Center San Antonio.

#### **DISCUSSION:**

Mayor Nirenberg asked City Manager Walsh to restate the staff recommendation. City Manager Walsh stated that the recommendation was to award 59 agencies \$36,450,000; with the remaining \$3,700,000 unallocated funding returned to the City Council Committees for reevaluation of priorities. Mayor Nirenberg recommended starting preliminary evaluation with the Governance Committee.

Councilmember Cabello Havrda made the main motion to approve the staff recommendation except for funding for Child Advocates San Antonio, Communities in Schools, and Older Adults Technology Services due to recusals.

Councilmember Rocha Garcia spoke in support of the recommendations and mentioned that the San Antonio Housing Trust had a plan for upstream services particularly for youth aging out of foster care. Councilmember Rocha Garcia asked a youth to speak about her experience with the

Bexar County Fostering Educational Success Program.

Councilmember Cabello Havrda spoke in support of the program and thanked everyone who came to speak and commented that funding for Mental Health was recommended by the Public Safety Committee which she chaired. She appreciated the agencies that came to speak and the work of all of the non-profits, even those not being recommended, noting that the number of applications received was overwhelming which indicated the immense need for services. Councilmember Cabello Havrda praised the work assisting youth aging out of foster care.

Councilmember Pelaez noted that some agencies were excluded because of the category which they applied for or because they included capital funding requests. Assistant City Manager Houston stated that only the non-profit social services category included funding for non-professional financial hardship and infrastructure needs. Councilmember Pelaez recommended that agencies who did not receive funding should be provided a debrief so they could improve their proposals to be successful later.

Councilmember Pelaez recommended making a more intentional effort to prioritize and fund domestic violence. City Manager Walsh stated that Councilmembers could make changes on the dais, but added that staff followed the process and priorities outlined. City Manager Walsh agreed that domestic violence was an important issue to address.

Councilmember Pelaez moved to reduce funding for University of Texas Health Science Center at San Antonio (UTHSCSA), the University of Texas at San Antonio (UTSA), and Communities in Schools (CIS) each by \$100,000 to fund \$150,000 each to For Her and Child Safe. The amendment was seconded by Perry.

Councilmember Viagran stated that although she supported For Her and Child Safe she recommended going back to the Council Committees or B Session to discuss priorities. Councilmember Viagran supported moving forward with the staff recommendation now.

Councilmember Cabello Havrda expressed concern that removing \$100,000 from each of the three agencies would adversely impact their services. Councilmember Cabello Havrda noted that domestic violence had received a prior ARPA allocation, though she acknowledged that it was not enough. She invited Child Safe CEO Kim Abernethy to speak. Abernethy stated that she appreciated Councilmember Pelaez' support but did not want to take money from other agencies.

Councilmember Courage stated that even though he supported funding for Child Safe, he did not support reducing funding for Communities in Schools.

Councilmember Castillo thanked staff for their work on taking City Council direction to get us to this point. She appreciated the efforts of all the agencies who had submitted proposals as they all did important work. Councilmember Castillo supported funding to reduce domestic violence and noted that funding the services could help in those efforts so she did not support Councilmember Pelaez' motion and further recommended looking at the remaining funds to provide more help.

Councilmember McKee-Rodriguez commented that the amendment was in poor taste because it

ignored the process. He supported reducing funding for UTSA and UTHSCSA to go back into the unallocated pot for additional discussion by Council Committees.

Councilmember Bravo did not support Councilmember Pelaez' amendment as it could take funding away from important programs. Councilmember Bravo noted that he supported the work of Child Safe and For Her and suggested that those organizations could be funded with remaining funds.

Councilmember Perry stated that he seconded the motion just to hear the discussion but noted that staff and agencies that submitted applications had put a great deal of effort into the process and noted the number of proposals received and large amount of funding. Councilmember Perry stated that there were always winners and losers in every process as many agencies had professional grant writers.

Councilmember Perry did not support Pelaez' motion to amend.

Councilmember Pelaez thanked Child Safe for speaking up and honored their position that they did not want the money so he asked UTSA and UTHSCSA if they would be willing to shave \$75,000 off their proposals to give to For Her. Both agencies stated that they could not make the decision for their organizations today but any reduction in funding would negatively affect their programs.

Councilmember Pelaez withdrew his motion.

Councilmember Courage noted that 50 agencies received \$21 million through the regular DHS Delegate Agency process, and this funding was for 59 agencies and almost double the funding. Councilmember Courage commented that 20% of the residents of San Antonio lived in poverty and committed to working to ending poverty and improving the lives of people in San Antonio.

Councilmember Perry commented that the process had taken a long time to get the funding out the door and asked how much total ARPA money had been received and if there was any left. City Manager Walsh stated that the City had received \$326 million and noted that there would be a discussion next week at City Council with the "3+9 Budget Report" which would include remaining ARPA funds. Councilmember Perry requested a side by side list of existing delegate agencies against the amounts those agencies were recommended today for ARPA. Woosley stated that most of the agencies proposed different programs for ARPA than the regular services they provided through the General Fund contracts.

Councilmember Castillo requested clarification on which Committees the \$3.7 million would be returned to. Staff recommended \$3.4 million to Public Safety, \$240,000 to Economic & Workforce Development (EWDC), \$72,000 to Community Health Environment and Culture (CHECC).

Mayor Nirenberg recommended that the funding discussion be returned to the Governance Committee and then back to the Committees.

Councilmember Castillo strongly recommended more funding through CHECC to ensure equity.

Councilmember Viagran thanked the agencies that spoke for attending the meeting. She supported the recommendation and for the remaining funding to go back through the Committees for a review of the framework and re-prioritization.

Councilmember McKee-Rodriguez supported the staff recommendation but noted that he still had concerns about equity noting that there was \$13.1 million that never went through the process before the framework was approved. Councilmember McKee-Rodriguez commented that each Councilmember represented a single member district and he wanted to make sure the residents of Council District 2 would be served noting that today's presentation showed 17% of the services were targeted to Council District 2 which was positive. Councilmember McKee-Rodriguez pondered how we could celebrate Black History Month and not fund black organizations adding that 40% of the rejected proposals were from Council District 2.

Councilmember Bravo spoke in support of the staff recommendations and noted that yesterday's briefing on the Violent Crime Reduction Plan included many of these services. Councilmember Bravo asked if the Governance Committee could change the allocations and recommended that the \$3.4 million stay in the Mental Health category.

Councilmember Rocha Garcia supported determining the appropriate Committee and requested clarification on the process to be brought before the Governance Committee. City Manager Walsh suggested that discussions would occur before next week's B session during the "3+9 Budget Report."

Councilmember Pelaez asked how the funding would be distributed and requested information on the proposed dashboard. City Manager Walsh stated that staff would provide regular updates. Deputy City Manager Maria Villagomez stated that a full report on ARPA expenditures would be provided to the U.S. Department of the Treasury.

Councilmember Perry requested clarification on contract negotiations and metrics, stressing that outcomes should be measured. Higgins provided a slide on the Mental Health Service Plan equitable outcomes and noted that progress would be checked through contract monitoring, desk reviews and audits. Councilmember Perry reminded the agencies that this was one-time funding for two years.

Councilmember McKee-Rodriguez clarified that the remaining funding would go back to the Governance Committee and work would occur in Committee noting that Council Districts 1, 2, 3, and 5 were not represented on the Governance Committee. City Manager Walsh commented that City Council could provide direction next week in B Session.

Mayor Nirenberg closed the discussion by reminding everyone that the American Rescue Plan Act was the first bipartisan Federal legislation to help communities recover from the COVID-19 Pandemic. Mayor Nirenberg commented that he had attended an event hosted by the organization For Her and the program deserved a second look and would have an opportunity with the \$3.7 million. However, Mayor Nirenberg added that the list of needs was very long and there were never enough resources to match the community need. Mayor Nirenberg called on the community to help with volunteer and philanthropic resources to help the agencies as well as government

# **City Manager's Report**

#### **16.** City Manager's Report

City Manager Erik Walsh provided an update on the Point in Time Homeless Count conducted by homeless serving agencies and provided clarification on the role of warming centers to serve residents impacted by power outages but homeless individuals were always served by the non-profit partners. City Manager Walsh commented that Volunteer Income Tax Assistance (VITA) had returned to work. City Manager Walsh played an Employee Spotlight Video featuring David Whitt,

Wellness Manager.

Councilmember Courage commented that the city helped transport people to the shelters. City Manager Walsh added that we could not force people to go. Councilmember Bravo requested data on the utilization of warming centers. City Manager Walsh reported that only 12-15 people went to the warming centers in December 2022. Councilmember Bravo expressed concern that there were so many residents that experienced power outages this week and we should have opened more warming centers to err on the side of making something available and not be used versus not providing necessary services.

Mayor Nirenberg requested assurance that anyone who needed and wanted shelter could receive it.
