

ORDINANCE

AMENDING A CONTRACT WITH UNIVERSAL PROTECTION SERVICES, LP DBA ALLIED UNIVERSAL SECURITY SERVICES (ALLIED) FOR SECURED AREA ACCESS MANAGEMENT AND MONITORING SERVICES AT THE SAN ANTONIO INTERNATIONAL AIRPORT TO EXTEND THE CONTRACT PERIOD SIX MONTHS FROM JUNE 30, 2024 THROUGH DECEMBER 31, 2024, OR UNTIL SUCH TIME AS A NEWLY-SELECTED RESPONDENT TO THE UPCOMING SOLICITATION IS FULLY TRAINED AND READY TO BEGIN OPERATIONS, WHICHEVER SHALL OCCUR FIRST.

WHEREAS, on May 30, 2019, City Council approved a five-year contract with Allied to provide the following services: monitoring of secured areas; conducting inspections; escorting within the secured areas; enforcing security guidelines; preventing and detecting unauthorized access; and, preventing any unauthorized items into the secured area; and

WHEREAS, the agreement expires on June 30, 2024, and a new solicitation of services is scheduled for release in April 2024; and

WHEREAS, this ordinance approves an amendment to the contract with Universal Protection Services, LP dba Allied Universal Security Services (Allied) for secured area access management and monitoring services at the San Antonio International Airport to extend the contract period six months from June 30, 2024 through December 31, 2024, or until such time as a newly-selected respondent to the upcoming solicitation is fully trained and ready to begin operations, whichever shall occur first; and

WHEREAS, funding for this extension in the amount of \$240,000, or \$80,000.00 per month, is available from the Airport Operating and Maintenance Fund FY 2024 Adopted Budget, with funding for the remaining portion of this extension subject to City Council approval of the annual budget; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or designee, is authorized to execute an amendment to the contract with Universal Protection Services, LP dba Allied Universal Security Services (Allied) for secured area access management and monitoring services at the San Antonio International Airport to extend the contract period six months from June 30, 2024 through December 31, 2024, or until such time as a newly-selected respondent to the upcoming solicitation is fully trained and ready to begin operations, whichever shall occur first, a copy of which is set out in **Exhibit 1**.

THIS IS A DRAFT AND WILL BE REPLACED BY THE FINAL, SIGNED
ORDINANCE OR RESOLUTION ADOPTED BY CITY COUNCIL.

SECTION 2. Funding in the amount of \$240,000.00 for this ordinance is available in Fund 5101000, Cost Center 3305040004 and General Ledger 5208530 as part of the Fiscal Year 2024 Adopted Budget approved by City Council.

SECTION 3. Additional funding is contingent upon City Council approval of the Fiscal Year 2025 budget.

SECTION 4. Payment is authorized to Universal Protection Services, LP dba Allied Universal Security Services (Allied) and should be encumbered with a purchase order.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 6. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
