# Solicitation Overview



The Public Works Department solicited a Request for Qualifications (RFQ) for up to five firms to provide On-Call National Environmental Policy Act (NEPA) consulting services for federal transportation projects, bond funded projects, and other City projects. These services may include but not limited to environmental document preparation in accordance with Texas Department of Transportation (TxDOT) and Federal Highway Administration (FHWA) requirements, Clean Water Act Section 404 permitting and other requirements.
