

ORDINANCE

AMENDING THE PROFESSIONAL SERVICE AGREEMENT WITH TELOS IDENTITY MANAGEMENT SOLUTIONS LLC TO EXTEND THE CONTRACT TERM TO SEPTEMBER 30, 2026 AND INCREASE THE CONTRACT VALUE IN THE AMOUNT NOT TO EXCEED \$250,000 TO CONTINUE DESIGNATED AVIATION CHANNELING SERVICES FOR THE SAN ANTONIO AIRPORT SYSTEM, WITH FUNDING AVAILABLE IN THE FY 2024 AIRPORT OPERATIONS AND MAINTENANCE FUND BUDGET AND FUNDING FOR SUBSEQUENT YEARS CONTINGENT UPON CITY COUNCIL APPROVAL OF THE ANNUAL BUDGET.

WHEREAS, in 2019, the Airport System initiated a program to streamline the management of airport staff's IDs (badges) and end-to-end credentialing, auditing and reporting rather than utilizing separate systems that are not integrated through an Identity Manager System, referred to as IMS; and

WHEREAS, one major component to the IMS system is the Designated Aviation Channeling (DAC) service provider, Telos; and

WHEREAS, Telos is an approved vendor by the Transportation Security Administration that provides a system for security personnel at airports to perform fingerprint-based criminal history record checks and security threat assessments for prospective and current badge-holders ; and

WHEREAS, with the upcoming expiration of the contract for the IMS system, the San Antonio Airport System would like to review its options in consideration of a new IMS which may or may not utilize Telos as the DAC service provide; and

WHEREAS, this proposed amendment will allow additional time for the Aviation Department and ITSD department to review the various components of the Airport System's security program and recommend a course of action to ensure all components are compatible and their contract terms are aligned; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or designee, is authorized to execute an amendment to the professional services agreement with Telos Identity Management Solutions LLC to extend the contract term by two years and five months to September 30, 2026 and increase the contract value in the amount of \$250,000 to a new contract value of \$1,383,621.32 to continue their Designated Aviation Channeling services for the San Antonio Airport System, a copy of which is set out in **Exhibit 1**.

ORDINANCE OR RESOLUTION ADOPTED BY CITY COUNCIL.

SECTION 2. Funding in the amount of \$250,000.00 for this ordinance is available in Fund 5101000, Cost Center 3305040004 and General Ledger 5201040 as part of the Fiscal Year 2024 Adopted Budget approved by City Council.

SECTION 3. Additional funding is contingent upon City Council approval of the Fiscal Year 2025 and subsequent budgets that fall within the contract terms of this ordinance.

SECTION 4. Payment of the new contract value in the amount of \$1,383,621.32 is authorized to Telos Identity Management Solutions LLC and should be encumbered with a purchase order.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 6. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
