ORDINANCE

**APPROVING A CONTRACT WITH AUSTIN ARMATURE WORKS LP
TO PROVIDE ELEVEN SEWAGE EJECTOR PUMPS FOR THE HENRY
B. GONZALEZ CONVENTION CENTER FOR \$62,460.80. FUNDING IS
FROM THE HOTEL OCCUPANCY TAX FUND AND INCLUDED IN THE
FY 2024 - FY 2029 CAPITAL IMPROVEMENT PROGRAM.**

WHEREAS, bids were submitted for the purchase and delivery of eleven sewage ejector pumps for the Henry B. Gonzalez Convention Center; and

WHEREAS, Austin Armature Works LP, submitted the low bid for a total cost of \$62,460.80;
NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bid submitted by Austin Armature Works LP, for a total cost of \$62,460.80 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation is attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Payment not to exceed \$62,460.80 is authorized to be encumbered with a purchase order and made payable to Austin Armature Works LP to provide eleven (11) sewage ejector pumps at the Henry B. Gonzalez Convention Center. Payment is in support of Project 42-00064 HBGCC Lift Station using WBS element 42-00064-05-05-02-01 with GL Account 5204050. Funding is provided by the Hotel Occupancy Tax Fund and is in the FY 2024 - FY 2029 CIP Budget.

SECTION 3. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
