Call to Order / Roll Call

3. Arts Funding: Panelists Recommendations (Action)

Dlugosz provided an overview of the panelist evaluation process followed by applicant demographics including applicant location and range of experience and stated panelist recommendations are for a three-year term. Dlugosz presented a list of all the panelists recommended by staff and approved by the Art Funding Committee.

6. Performing Arts, Film and Music: Music Program Updates (Briefing)

Hill briefed the Commission on the *Local Music Spotlight Program* stating the program now has three enrollment rounds per fiscal year. This first round attracted eight musicians, with eight songs selected by a panel of members from the Performing Arts, Film and Music Committee. A list of musicians/bands and titles of their songs were presented. Each musician is due to receive a two hundred fifty-dollar honorarium for the City of San Antonio's non-exclusive use of their song(s) on City channels. The second enrollment round is now open due to close on April 26, 2024, with the final and third enrollment round due to open this Summer.

Hill announced to the Commission the Department of Arts & Culture will manage the City of San Antonio's participation in *Make Music Day* scheduled this year for Friday, June 21. This is a worldwide celebration of free music. The concept includes local musicians, venues and organizations hosting free music programming open to the public. The Department is partnering with Texas Public Radio to have a local music spotlight stage on the San Pedro Creek. 7. Performing Arts, Film and Music: Filmmaker Artist Forum Update (Briefing)

Hill briefed the Commission on the Texas Public Radio partnership event: *TPR Artist Forum* hosted on February 24 at 6 p.m. This free and open to public event provided a networking forum, free headshots, a moderated discussion panel on filmmaking, locations scouting and management advice from the panelist.
