

Amendment to Ordinance 58134 (01/12/1984)

Section 2. The function of the Transportation Advisory Board shall be as follows:

CURRENT:

To review staff recommendations, conduct hearings, recommend guidelines, and make recommendations to the City Council on the licensing and regulatory review process for transportation services licensed by the City. These services include taxicabs, limousines, tow wreckers, tour/sightseeing operations, and horse carriages.

Amendment:

To review staff recommendation and make recommendations to the City Council, Chief of Police, and/or Aviation Director on Chapter 3, Chapter 33, Rules and Regulations, and internal operations/policies on the licensing and regulation of the ground transportation services licensed by the City. These services shall include ground transportation services outlined in Chapter 3 and/or Chapter 33.

Section 3. The Transportation advisory Board shall address the following transportation Services:

CURRENT:

1. The procedures and need for additional service or permits.
2. Service regulations – the quality and terms of the service to be provided.
3. Permit holder and driver regulations – the fiscal and public safety requirements.
4. Fares and permit/license fees – the level and basis thereof.
5. Appeals – hearing appeals from drivers and permit holders regarding sanctions imposed by staff.
6. Such other matter as request by the City Council.

Amendment:

1. The procedures and need for additional service or permits.
2. Service regulations – the quality and terms of the service to be provided.
3. Permit holder and driver regulations – the fiscal and public safety requirements.
4. Fares and permit/license fees – the level and basis thereof.
5. Such other matter as request by the City Council, Chief of Police, or Aviation Director

Amendment to Ordinance 2009-05-21-0433

Section 3. The voting membership of the TAB Shall be composed of the following:

CURRENT:

- Three Consumers of the ground transportation industry.
- One owner, permitted driver, or employee of a large taxicab company (i.e., a company whose operating permit authorizes the operation of twenty or more vehicles.).
- One owner, permitted driver, or employee of a small taxicab company (i.e., a company whose operating permit authorizes the operation of less than twenty vehicles).
- One member of a taxicab cooperative.
- One owner, permitted driver, or employee of a tour, charter, or shuttle company.
- One owner, permitted driver, or employee of a horse carriage, limousine, or livery company.
- One member of the San Antonio Airport Advisory Commission.
- One member of the San Antonio Convention and Visitors Commission.
- One member of the San Antonio Hotel and Lodging Association.

Amendment:

- Five Consumers of the ground transportation industry.
- One owner, permitted driver, or employee of a taxicab company.
- One member of a taxicab cooperative or a permitted owner/operator of a taxicab.
- One owner, permitted driver, or employee of a horse carriage, Electric Vehicle-for-hire, Pedicab, group cycle, or motorbike sidecar company.
- One owner, permitted driver, or employee of a limousine, tour, or charter company.
- One representative from Visit San Antonio.
- One member of the San Antonio Hotel and Lodging Association.
