**ORDINANCE**

**APPROVING A CONTRACT WITH CANTU CONTRACTING, INC., FOR ACREAGE SHREDDING SERVICES FOR THE SAN ANTONIO FIRE DEPARTMENT FOR AN ESTIMATED COST OF \$61,920.00 ANNUALLY AND AN ESTIMATED TOTAL COST OF \$309,600.00 OVER THE CONTRACT TERM. THE INITIAL TERM WILL BEGIN UPON AWARD AND END DECEMBER 31, 2026, WITH TWO, ADDITIONAL ONE-YEAR RENEWAL OPTIONS. FUNDING IS FROM THE GENERAL FUND. FUNDING FOR SUBSEQUENT YEARS IS CONTINGENT UPON CITY COUNCIL APPROVAL OF THE ANNUAL BUDGET.**

**WHEREAS**, the City released a Request for Competitive Sealed Proposals (RFCSP) to provide the City of San Antonio with acreage shredding services for the City's San Antonio Fire Department (SAFD) in order to maintain and ensure designated areas are clean and safe for emergency access to fire facilities; and

**WHEREAS**, three proposals were received and evaluated; and

**WHEREAS**, staff recommends Cantu Contracting, Inc., for award of a contract based on the City's standard RFCSP evaluation process; and

**WHEREAS**, approval of this ordinance will authorize a contract beginning upon award and ending December 31, 2026, with the option for the City to renew for two additional, one-year periods, for an estimated annual cost of \$61,920.00, and an estimated total cost of \$309,600.00 for the entire contract period including renewal options; and

**WHEREAS**, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The proposal submitted by Cantu Contracting, Inc., to provide the City of San Antonio with acreage shredding services for the City's San Antonio Fire Department for an estimated annual cost of \$61,920.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. A copy of the Score Summary and RFCSP is attached hereto and incorporated herein for all purposes as **Exhibit I**.

**SECTION 2.** Funding for this ordinance in the amount of \$61,920.00 is available in Fund 11001000, Cost Center 2015130001 and General Ledger 5204050 as part of the Fiscal Year 2024 Adopted Budget approved by City Council.

**SECTION 3.** Additional funding is contingent upon City Council approval of the Fiscal Year 2025 and subsequent budgets that fall within the term of the contract.

**SECTION 4.** Payment is authorized to Cantu Contracting, Inc., and should be encumbered with a purchase order.

**SECTION 5.** The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

**SECTION 6.** This ordinance is effective immediately upon passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.
