

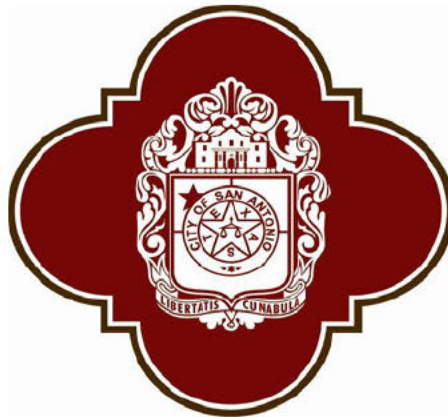

**SUBJECT:**

Consideration of nine (9) At-Large Applicants to the Airport Advisory Commission

**SUMMARY:**

The Transportation and Infrastructure Committee will review and consider applicants to the Airport Advisory Commission (9 At-Large seats). Appointees will serve a term of office to begin upon approval by the City Council and to expire on March 18, 2026.

**BACKGROUND INFORMATION:**

The purpose of the Airport Advisory Commission (AAC) is to advise the Aviation Director on matters affecting the San Antonio Airport System and air transportation initiatives.

The Airport Advisory Commission is comprised of 19 members appointed by City Council At-Large for staggered two-year terms. Currently, there are 18 members on the Commission, one vacant position, and 8 positions whose terms expired on March 18, 2026.

The current composition of the AAC is as follows:

- Alamo Area Council of Governments (AACOG): 1 seat - filled
- Airport Business – Lessee: 1 seat - filled
- Aviation Industry: 3 seats – 1 seat filled, 1 seat in holdover, and 1 seat vacant,
- Business Community: 4 seats – 3 seats filled and 1 seat in holdover
- Community: 6 seats - 3 seats filled and 3 seats in holdover
- Federal Aviation Administration: 1 seat – 1 seat in holdover
- Ground Transportation Industry: 1 seat – filled
- Travel and Tourism Industry: 2 seats – 1 seat filled and 1 seat in holdover

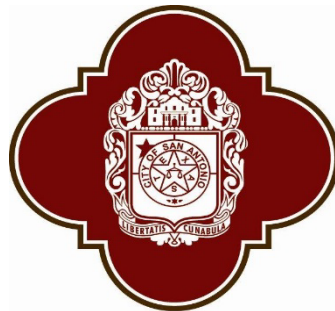

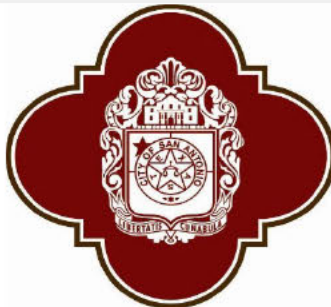
