Whereas, the City of San Antonio (City) entered into a contract with The New York Times Company for the continuation of the NY Times.com annual subscription utilized by the San Antonio Public Library (SAPL) which began on February 23, 2022 and terminates February 20, 2024 (the “Contract”); and

Whereas, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(7)(A), which provides for any items that are available only from a sole source of supply, and

Whereas, this amendment is authorized with City Council approval pursuant to the section entitled “Amendments” in 006, General Terms & Conditions, of the above referenced contract, and the Contract is hereby amended as follows:

1. AMENDMENTS

- A. Section 004- Specifications / Scope of Services, is hereby revised to upgrade to “All Access” with 30,000 Single Code multi-redeems per year, replacing the previous code for offsite activations applicable only to News Only access.
- B. Section 005- Supplemental Terms & Conditions, Original Contract Term, is hereby revised to renew the Contract for a three-year period and reads as follows:

Contract Term:

This Contract began on February 23, 2022, and terminates on February 23, 2027.

- C. Attachment A – Price Schedule is revised to add:
 - a. NYTimes.com Subscription Term February 23, 2024- February 23, 2025, for \$27,144.00
 - b. NYTimes.com Subscription Term February 23, 2025- February 23, 2026, for \$27,664.00

c. NYTimes.com Subscription Term February 23, 2026- February 23, 2027, for \$28,184.00

2. PROVISIONS REMAIN IN EFFECT

All other terms, conditions, covenants and provisions of the above referenced contract, as previously amended, not specifically mentioned herein and revised by this document, are retained in their entirety, unchanged, and remain in full force in effect for the duration of said contract, and any renewals thereof.

3. ENTIRE AGREEMENT


