

## ORDINANCE

### **APPROVING THE SETTLEMENT *ALEXANDER LANCE V. RODOLFO CONTERO, ET. AL.*, CAUSE NUMBER SA-21-CV-00837-JKP, IN THE AMOUNTS OF \$118,800.00.**

**WHEREAS**, on May 30, 2020, the SAPD SWAT team was dispatched to patrol downtown streets during demonstrations. Alexander Lance was observed by an officer who believed he was about to throw an object at the officers. The SWAT officer discharged his weapon, striking Mr. Lance twice with sponge rounds; and

**WHEREAS**, as a result of this accident, Alexander Lance alleges he suffered injuries and incurred medical expenses, and filed suit seeking to recover damages; and

**WHEREAS**, although the City of San Antonio and Defendant officers have vigorously contested this matter, it is in the City's best interest to settle this matter to avoid the uncertainties and risks associated with further litigation; and

**WHEREAS**, the parties have reached an agreement to settle the claim of Alexander Lance in the amount of \$118,800.00, payable from the Self-Insurance Liability Fund subject to City Council approval; **NOW THEREFORE:**

### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The amount of \$118,800.00 is authorized to be paid from Fund 75001000, Insurance Reserve Fund, General Ledger 5402530 General Liability Claims, Cost Center 7509020001 Risk Management- General Liability Claims, and is authorized to be made payable as follows: \$118,800.00 paid check to "Alexander Lance and the Law Offices of Maloney and Campolo, LLP."

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 3.** This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
