Rear brakes must be Meritor Refuse Brakes rear drum brakes 16.5 x 8.62; SBM Valve. Heavy duty brake drums with gusseted cam brackets. A power divider lockout w/warning light and buzzer (includes in cab manual air valve) shall be equipped for safety. The rear axle lubricant shall be 75-90 Synthetic with transverse torque rods and (4) shock absorbers (both axles).
