SUMMARY:

Discussion and possible action on SEP-HCP application for VANTAGE DATA CENTERS TX2, LLC (LAND-SEP-APP23-46900003)

BACKGROUND INFORMATION:

LOCATION:

This project is located within northwestern Bexar County. The project consists of approximately 31.030 acres located between Rodgers Road, Wiseman Blvd, and State Highway 151, in San Antonio, Bexar County, Texas.

VANTAGE DATA CENTERS TX2, LLC is considering the future development of the Project Area. As such, the Applicant wishes to enroll in the SEP-HCP to mitigate impacts to the SEP-HCP Covered Species from the development activities. The draft mitigation determination detailing the project is attached and a summary of the mitigation needs is included below.

The VANTAGE DATA CENTERS TX2, LLC Project Area includes 0 acres of golden-cheeked warbler (GCW) habitat with the Project Area and 0 acres of GCW habitat within 300 feet of the Project Area. The VANTAGE DATA CENTERS TX2, LLC Project Area will require a total of 0 GCW conservation credits (direct impacts at 2 credits:1 acre mitigation ratio = 0 conservation credits and indirect impacts at 0.5 credits:1 acre mitigation ratio = 0 conservation credits).

The VANTAGE DATA CENTERS TX2, LLC Project Area does not have any black-capped vireo (BCV) habitat and will not require any BCV conservation credits.

The VANTAGE DATA CENTERS TX2, LLC Project Area is located over Karst Zone 2 and totals 31.030 acres. The Project Area is not located within any Critical Habitat Units nor is it within 750-ft of any occupied features.

Participation in the SEP-HCP for this application will require the following:

- GCW Conservation Credits Fee of \$0.00
- Karst Zone 1 & 2 participation fee of \$31,030.00
- Karst Zone 3 & 4 participation fee of \$0.00
- Plan Administration Fee of \$3,103.00
- Total Karst Zone 1 & 2 Enrollment Acres needed for this project : 31.03
- 45.81 Karst Zone 1 and 2 enrollment acres are currently left in the Panther Springs Preserve
- 0.85 Karst Zone 1 and 2 enrollment acres are currently left in the Northern Preserve
- 295.64 Karst Zone 1 and 2 enrollment acres are currently left in the Crane Bat Cave Preserve

ISSUE:

The property subject to this application is entirely within Karst Zone 2. Therefore, the property is eligible for enrollment in the Southern Edwards Plateau Conservation Plan.

FISCAL IMPACT:

The applicant has paid the \$2,500 application fee. The applicant will be required to pay the full mitigation fee of \$34,133.00 prior to completing enrollment in the plan.

ALTERNATIVES:

The Southern Edwards Plateau Habitat Conservation Plan is voluntary. Should the applicant not enroll, the property owner could consult directly with the United States Fish and Wildlife Department (USFW) for Endangered Species Act (ESA) compliance.

RECOMMENDATION:

Staff recommends Approval of application SEP-LAND-SEP-APP23-46900003 VANTAGE DATA CENTERS TX2, LLC and issuance of the mitigation determination to the Applicant.
